The intention is to replace the steel ram pit covers with a standard fibre grate that is already used in other parts of the canal. The walls are constructed with a soft lime brick that has become eroded and unstable. The works would include concrete shuttering to stabilise the base and walls which would then be suitable to hold the fibre grate top. There are 3no each highlighted on the top view map that require these works.
