

THE ANCIENT MONUMENTS AND ARCHAEOLOGICAL AREAS ACT 1979 152
ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as **Glamis 2, cross slab 15m S of 10 Kirkwynd** comprises a Pictish cross slab dating probably to between about AD 700 and 1000. The stone stands 2.76m high and is 1.5m across by 0.24m thick, and is decorated on both faces with a variety of carvings, partly in shallow relief and partly with incised lines. The stone stands in the garden of 10 Kirkwynd, formerly Glamis Manse, about 30m W of the present church and 80m above sea level. The scheduled area is circular on plan, measuring 5m in diameter, centred on the stone, to include the remains described above and an area around them within which evidence relating to the monument's construction, use and abandonment may survive. The monument, which lies in the Parish of Glamis and the County of Angus as shown in red on the Plan annexed and executed as relative hereto and which forms part of the subjects registered in the Land Register of Scotland under Title No ANG40434

[REDACTED], is hereby included in the Schedule of Monuments appearing to the Scottish Ministers to be of national importance compiled and maintained by them under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

This entry supersedes the Entry in the Schedule of Monuments for the monument known then as **Upright Cross Slab at the Manse, Glamis** as referred to in the Certificate of Inclusion by the Commissioners of His Majesty's Works and Public Buildings in respect of the monument dated 24 April 1935 and recorded in the General Register of Sasines for the County of Forfar on 2 May 1935.

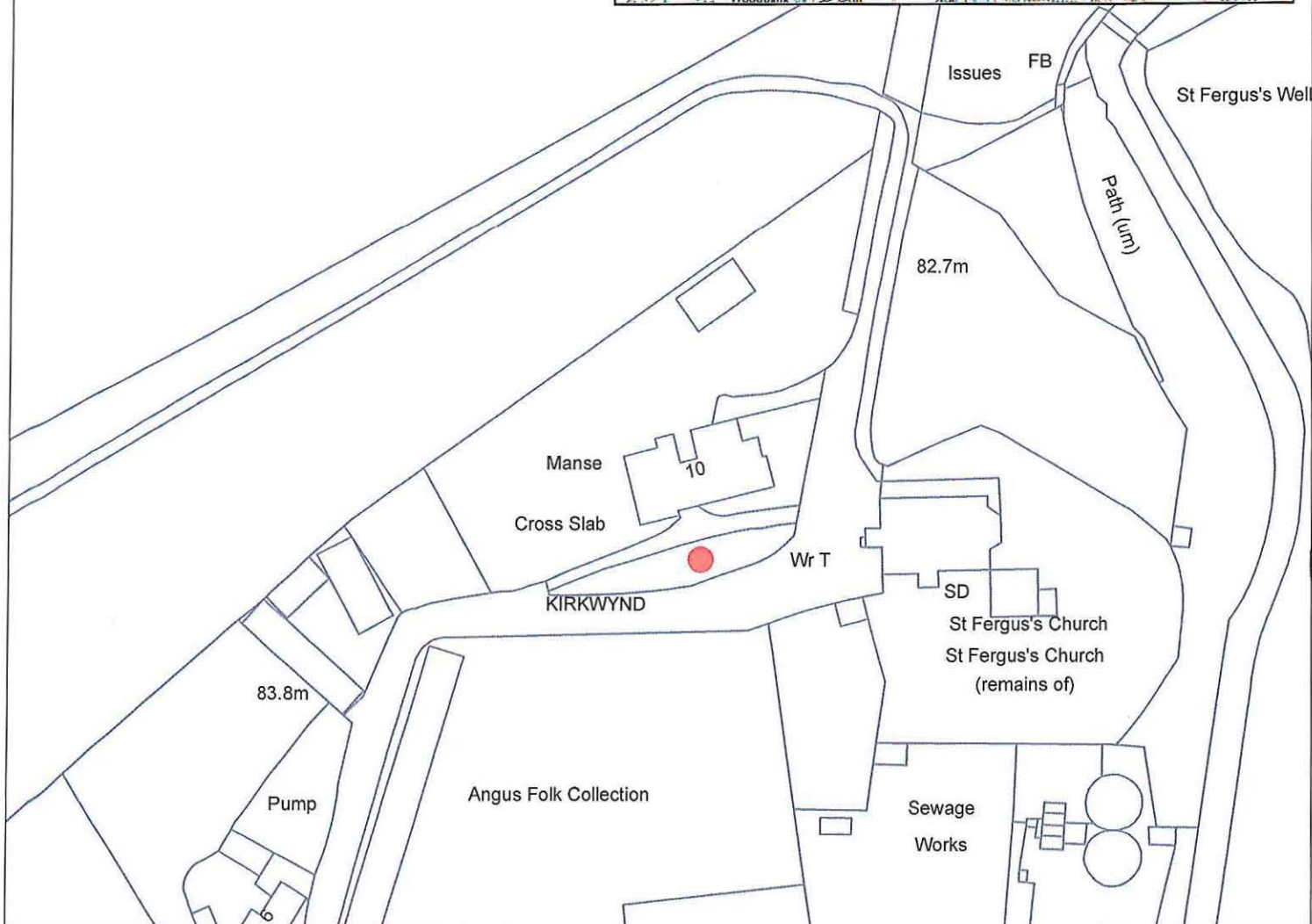
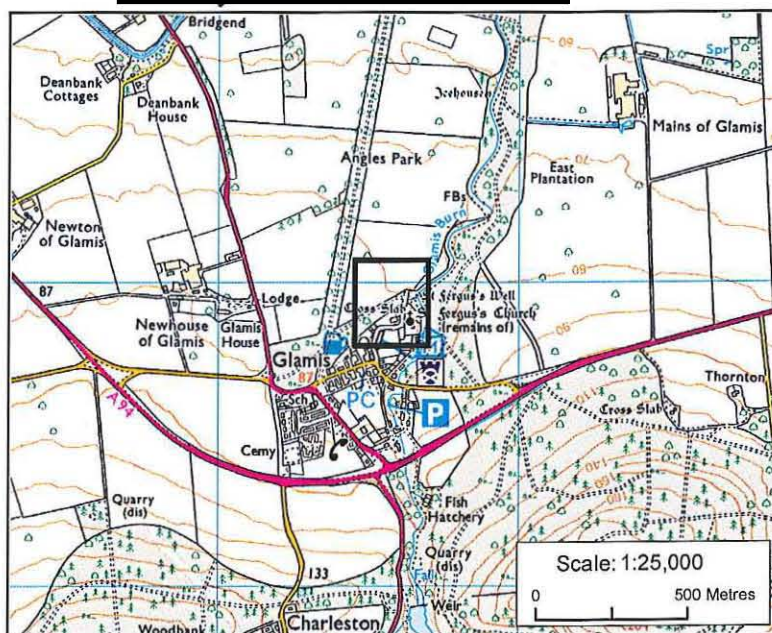
