

THE ANCIENT MONUMENTS AND ARCHAEOLOGICAL AREAS ACT 1979
ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as Hangman's Hill, cairn 380m E of Kinchyle, comprises a Bronze-Age burial cairn surrounded by a bank. It survives as an uncultivated island within improved pasture, lying at 100m above sea level on the N bank of the River Nairn, 220m E of Kinchyle. The monument comprises a scrub-and gorse-covered, sub-circular mound, measuring 25m in diameter and standing to a height of 3.3m. The area to be scheduled is circular, centred on the top of the mound, to include the remains described and an area around within which evidence relating to their construction and use may survive. The scheduled area extends up to, but does not include, the modern fence that runs from NE to SW adjacent to the SE perimeter of the mound. The monument, which lies in the Parish of Croy and Dalcross and the County of Nairn as shown outlined in red on the Plan annexed and executed as relative hereto

hereby included in the Schedule of Monuments appearing to the Scottish Ministers to be of national importance compiled and maintained by them under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

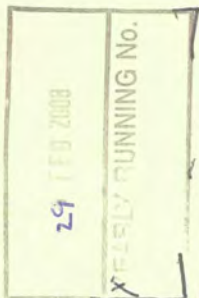
