Meetings regarding the Kirkmichael (Black Isle) Heritage Centre Project, incorporating re-use of the Gun Munro Mausoleum for a display of ornate gravestones and relocation of ornate gravestones within it, were held with Historic Scotland on: 20 June 2013 (Allan Rutherford and Nicki Hall); 2 June 2015 (Allan Rutherford, Shelagh Thorne, Frazer Gibson) and there have been numerous emails and updates.

4 Summary of proposed works (max 20 words)

Relocate additional gravestones to Gun Munro Mausoleum at Kirkmichael: one from Kirkmichael kirkyard and five from Cullicudden kirkyard.

Description of proposed works

As part of the Kirkmichael (Black Isle) Heritage Centre Project scheduled monument consent has been granted to repair the Gun Munro Mausoleum at Kirkmichael and relocate medieval and ornate gravestones within the repaired building. The Trust is now seeking to add more relocated stones to this display: another at risk stone at Kirkmichael, and the five highest at-risk stones at Cullicudden kirkyard in accordance with the attached Conservation Statement and Method Statement.

It should be noted that the application on behalf of the Kirkmichael Trust to repair the derelict buildings at Kirkmichael in the Black Isle, and to establish a display of ornate gravestones within the repaired "nave" or Gun Munro mausoleum, was approved on 28 June 2016. Reference: "Ancient Monuments and Archaeological Areas Act 1979 Scheduled Monument Consent Decision Notice Case ID 201600640 Index No M5419 Scheduled Monument St Michael's Church, Kirkton Location/Address Ross and Cromarty, Highland Proposed Works Conversion of a derelict church building to create a small heritage centre". The consent included relocation of two slabs from the kirkyard in Kirkmichael, the medieval "Kirkmichael Cross" and the "McCulloch Slab" from the 1700s, to within the Gun Munro mausoleum.
