## 1. Decision

In our current state of knowledge, the doocot, boundary wall and walled garden to Caroline Park (and to former Granton Castle) continues to meet the criteria for listing. The statutory listing address and the listed building record will be amended. The category of listing will remain at B.

## 2. Designation Background and Development Proposals

### 2.1 Designation Background

This walled garden was listed at category C on 14/12/1970. The listing was reviewed in 2015. The statutory listing address and listing building record were amended and the category was changed from C to B on 22/07/2015.

## 3. Assessment

### 3.1 Assessment information

The statutory listing address was proposed for amendment on 03/02/2016 to request that the structure was recognised by its correct name. Minor updates to the descriptive text have also been proposed.

A site visit was made to the walled garden on 18/03/2016 as part of a concurrent assessment of the wider grounds for the proposal to consider Caroline Park as an Inventory Garden and Designed Landscape (GDL). The landscape was not considered to meet the criteria for an Inventory GDL (see 300017871 on Historic Environment Scotland's portal <http://portal.historicenvironment.scot/>).

### 3.2 Assessment against designation criteria

An assessment against the listing criteria was not carried out.

The statutory listing address change currently proposed makes no material change to the listing as amended in July 2015.
