5 Description of proposed works

Change of specification from soft type 1 compacted stone to hard surfaced towpath by introducing Dense Bitumen MacAdam (DBM) and top dressing with 6mm stone chips.
Width of towpath upgrade same footprint as existing - 2.2 metres wide.
Methodology has been used over the last 10 years with great success.
