Installation of new interpretation panel adjacent to site on recreational path. The panel (attached) will be mounted on two timber posts (190mm x 90mm in thickness), dug into ground by spade to a depth of c. 600mm and spaced 1090mm apart. The proposed location is adjacent to the path at NH 6397 4522 (see attached plan) at the first sight of the monument. The proposed location is indicated on the

interpretation panel ('you are here') and is intended to aid orientation.
