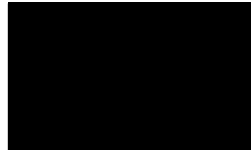

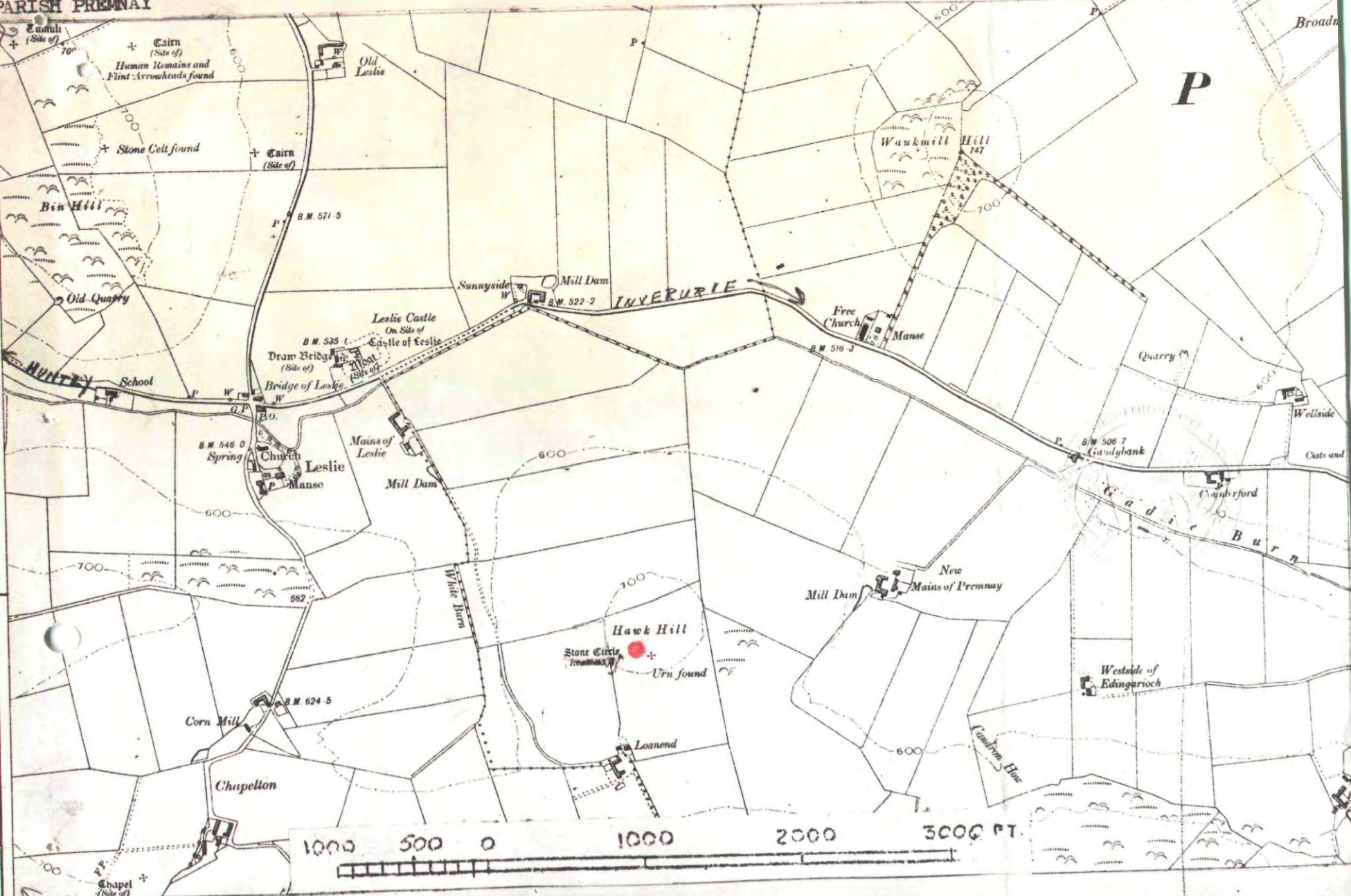

PARISH PREMAY

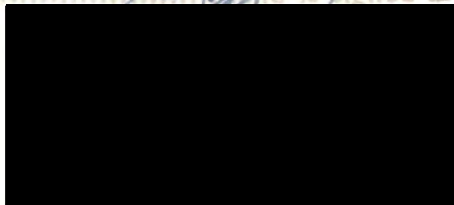


LOANEND STONE CIRCLE,
