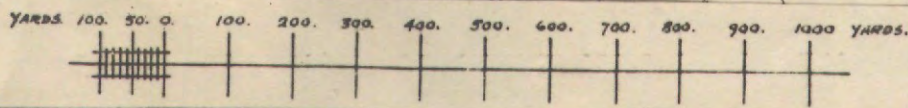
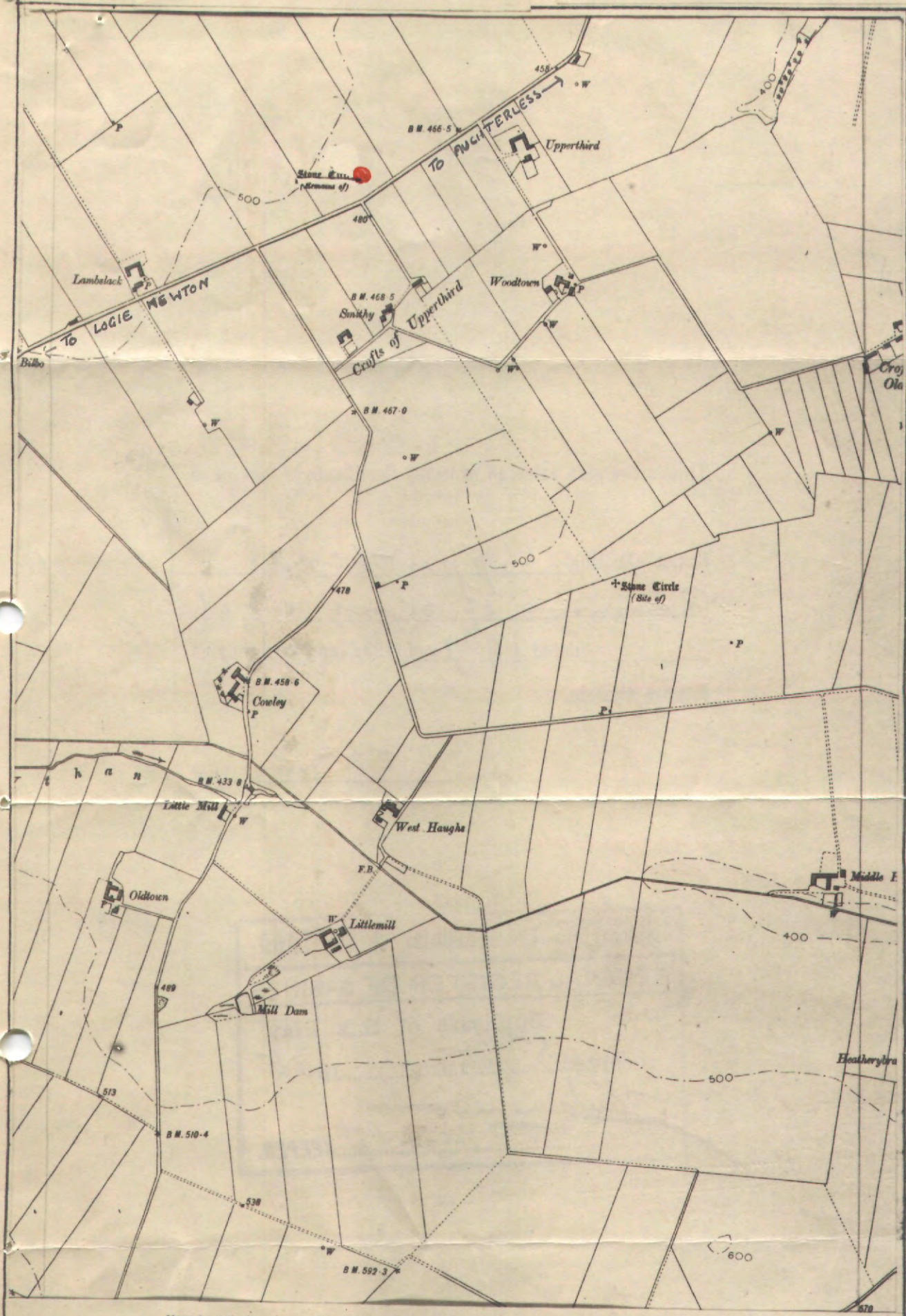

PLAN

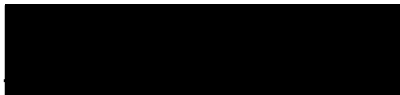


REMAINS OF STONE CIRCLE,
