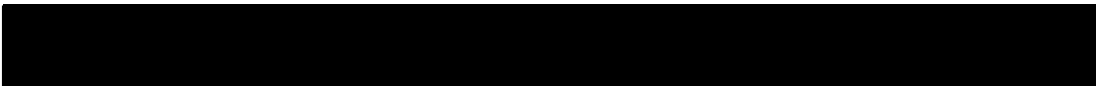

the owners of the Monument known as the Annand Memorial contained within a rectangular area of ground in the Parish Churchyard of Ellon measuring 14 ft. on each of its north and south sides and 2 ft. on each of its east and west sides, the westmost point of said area being situated 16 ft. east of the southeast corner of the Parish Church of Ellon; 50 ft. north by west of the south boundary wall of said graveyard at its nearest point and 90 ft. south-south-east of the entrance gates to said Churchyard

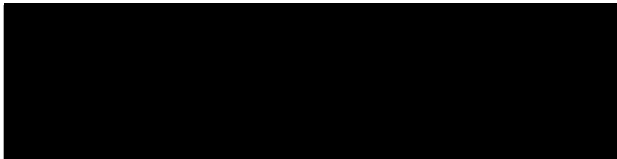
being the subjects indicated in red colour on the annexed plan and being part of the property known as the Parish Graveyard of Ellon

situated in the Parish of Ellon and County of Aberdeen.

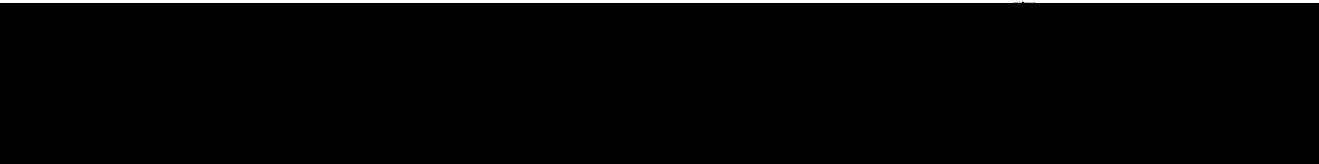

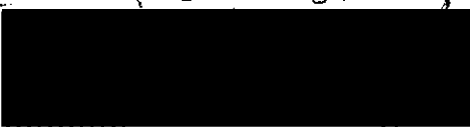

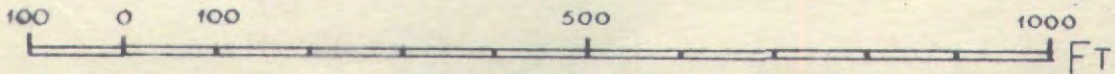
