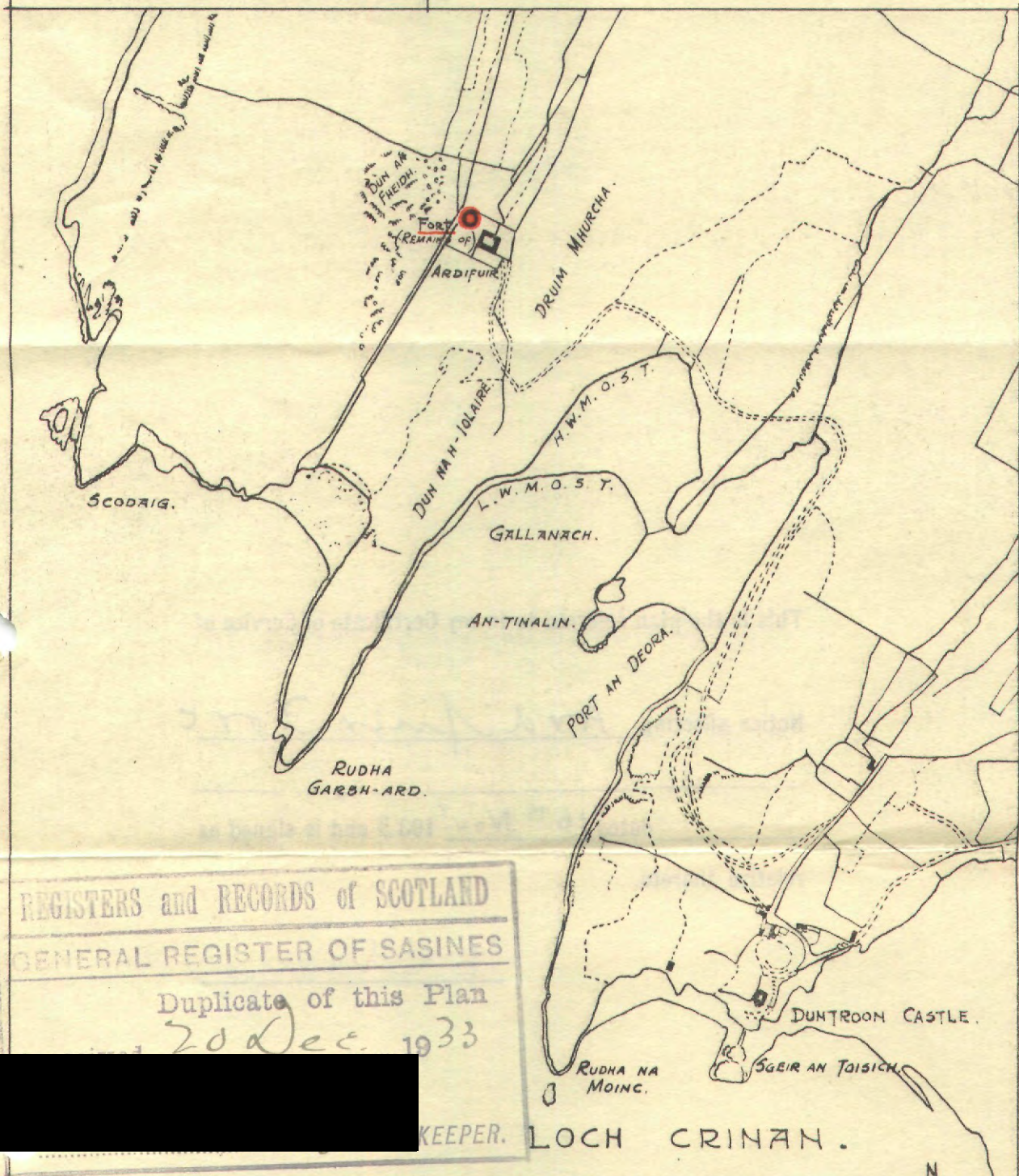

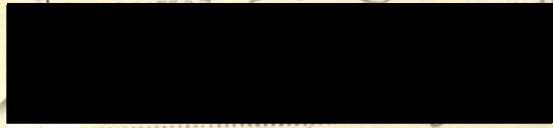
KILMARTIN PARISH.

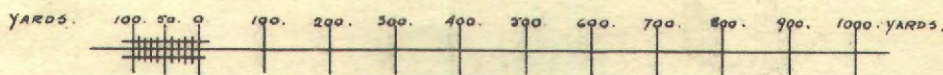
