being the subjects indicated in red colour on the annexed plan and being part of the property known as Alloa Old Kirkyard

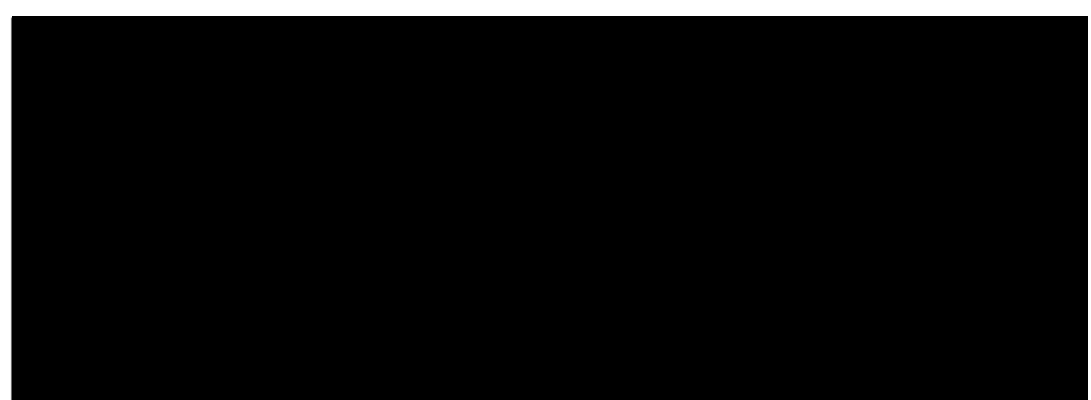
situated in the Parish of Alloa and County of Clackmannan.

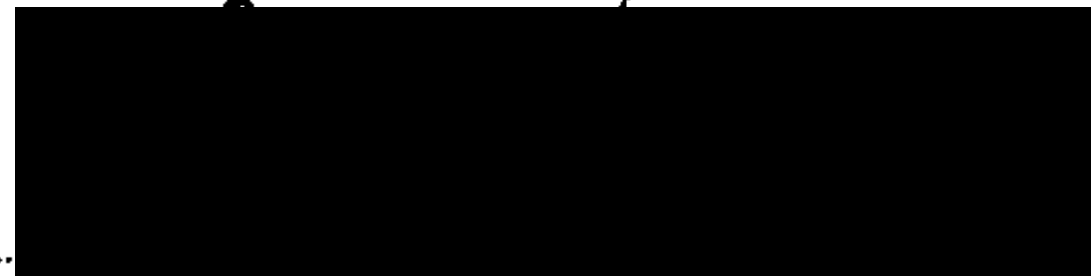

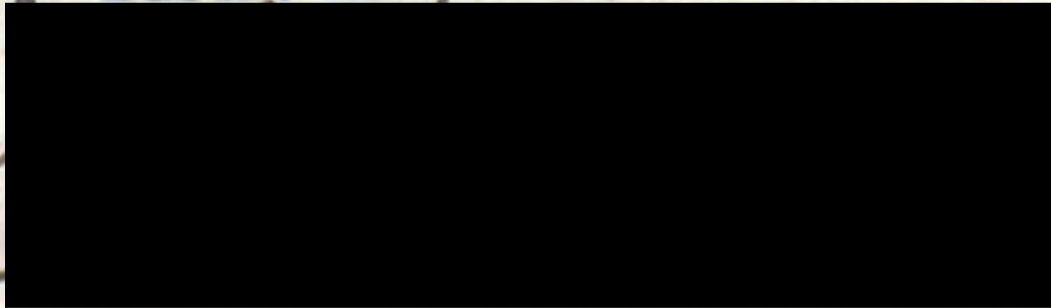
