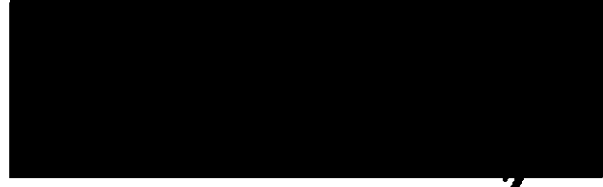
being the subjects indicated in red colour on the annexed plan and being part of the property known as **the Lands and Estate of Loganhouse**

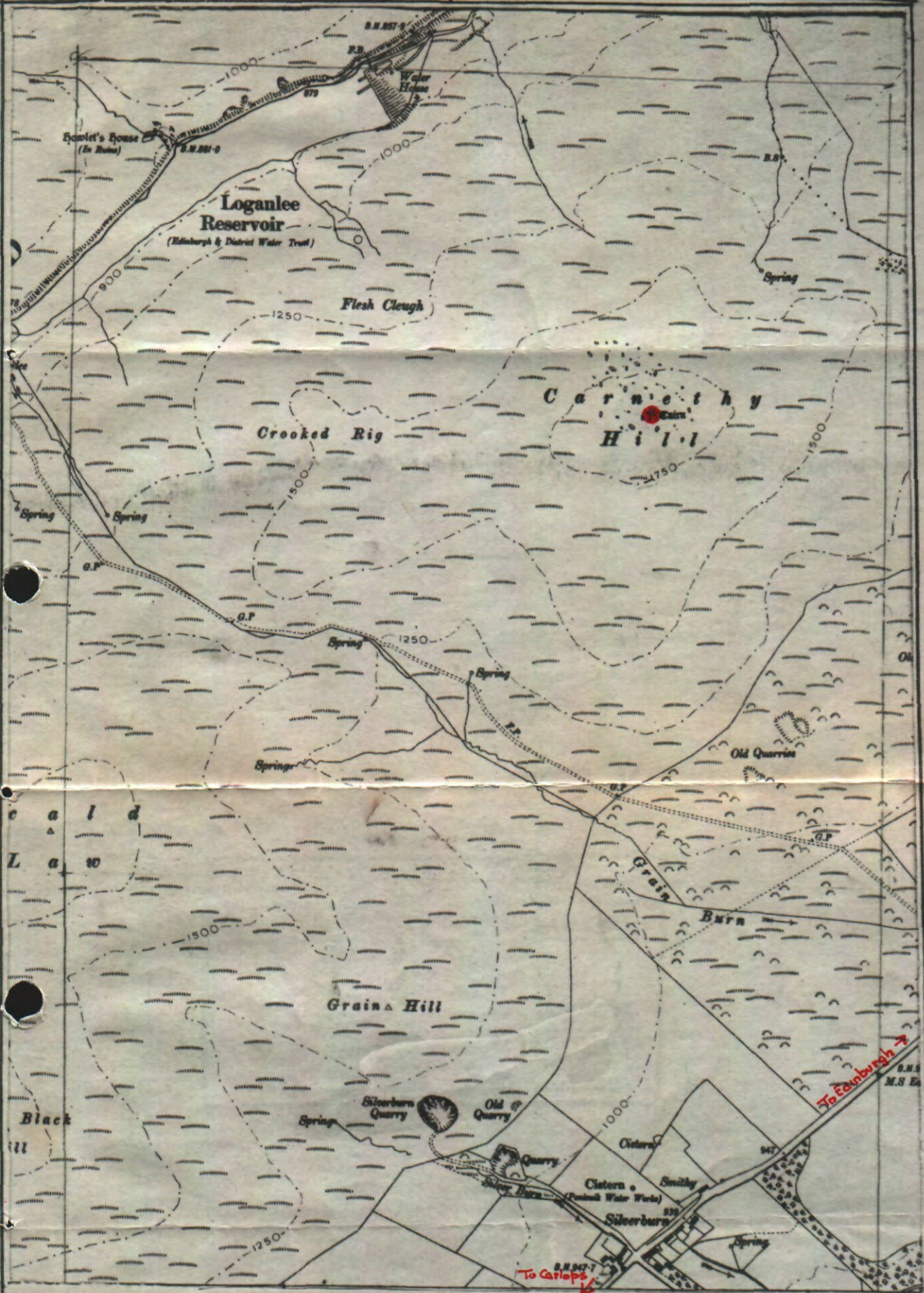
