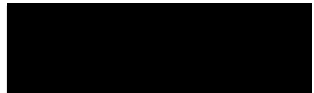
THE ANCIENT MONUMENTS ACTS, 1913 AND 1931

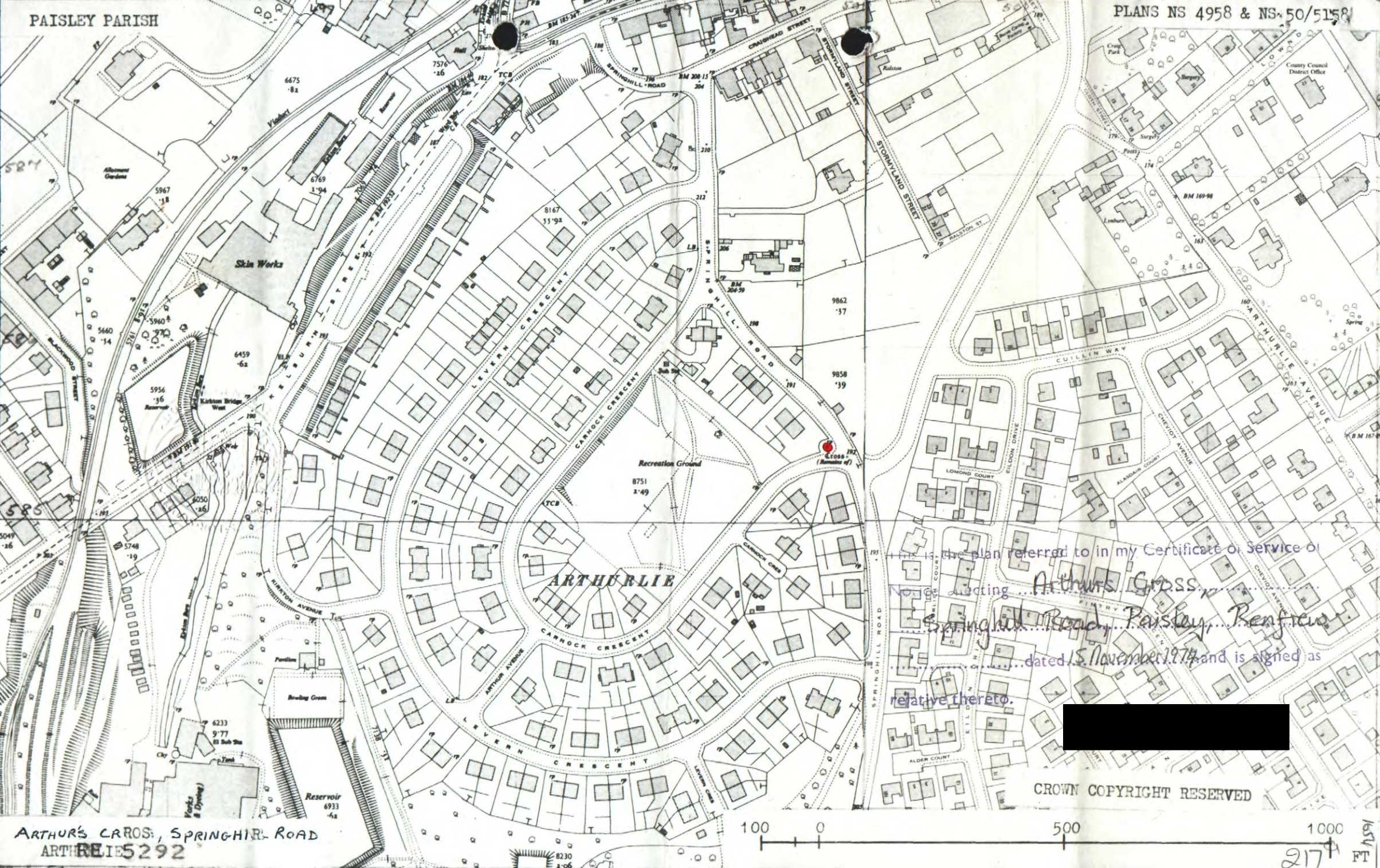
