the owners of the Monument known as "Dunan" (chambered cairn) situated 210 yards south-east of the Allt ant-Sniomh at its nearest point, 600 yards north-east of Loch na h'Inghinn at its nearest point, and 1230 yards west-south-west of the point where the public road on the east coast of Lewis crosses the mouth of the Amhuinn Aonghais

being the subjects indicated in red colour on the annexed plan and being part of the property known as Coll Farm

situated in the Parish of Stornoway and County of Ross and Cromarty.

In accordance with the provisions of Section 6 of the Ancient Monuments Act, 1931, the Commissioners of His Majesty's Works and Public Buildings hereby give you notice that it is their intention to include the Monument above specified in a list of monuments to be published by them under Section 12 of the Ancient Monuments Consolidation and Amendment Act 1913.
