situated in the Parish of Arbroath and St Vigeans and County of Angus

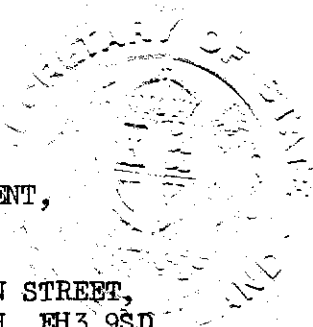

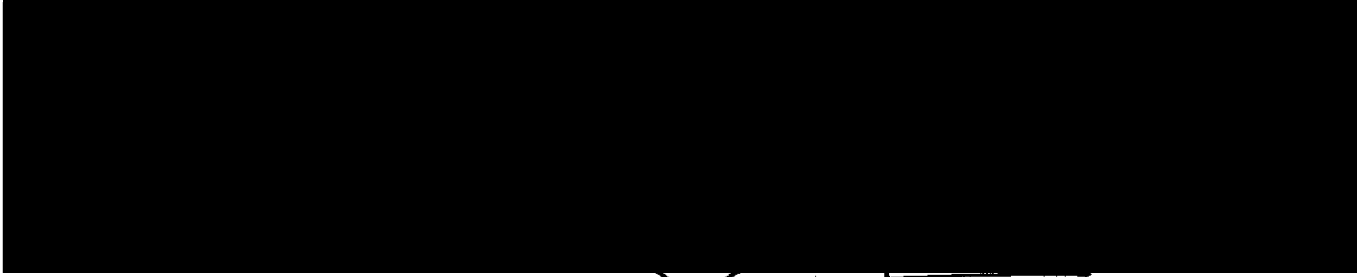

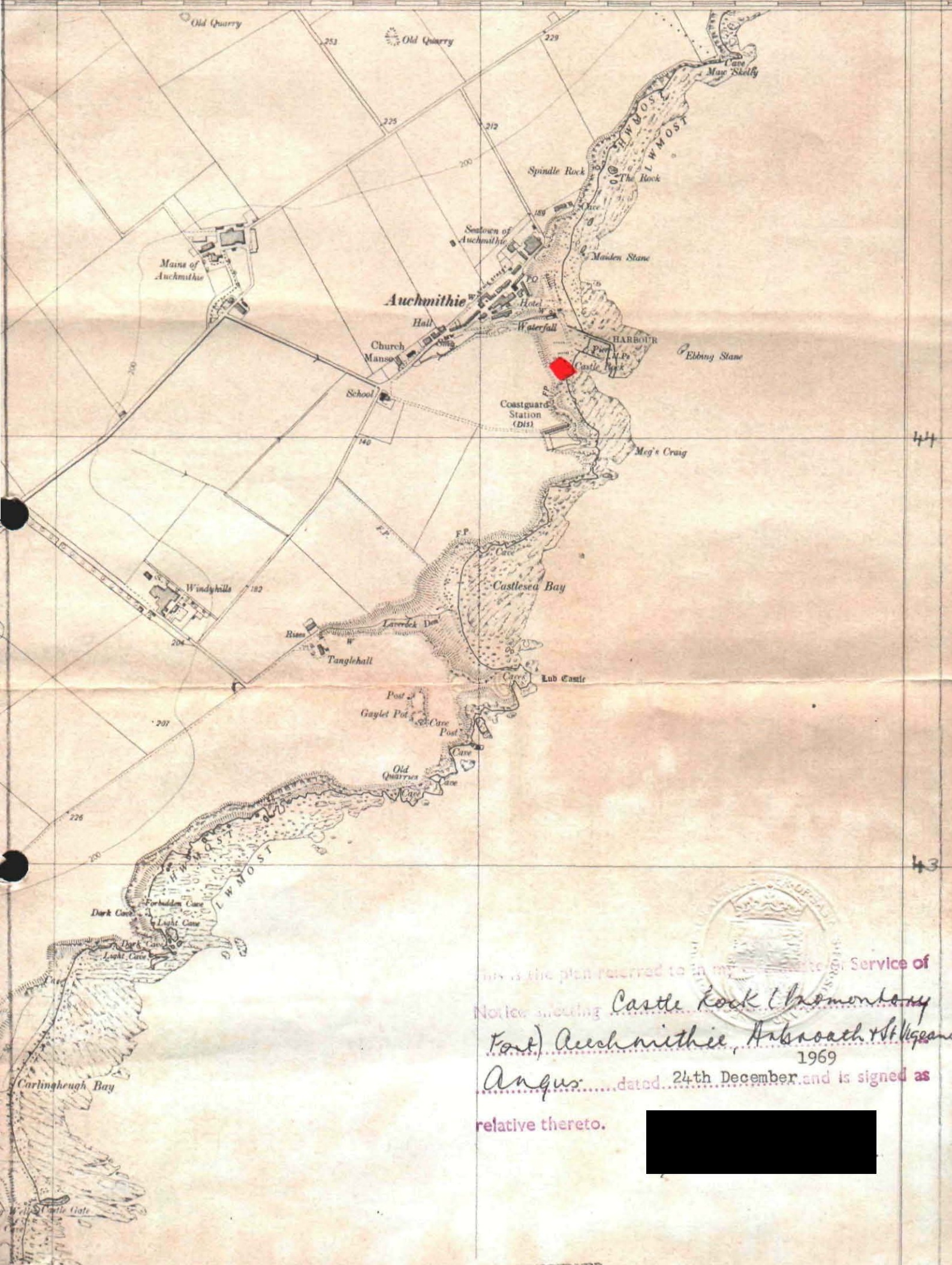
