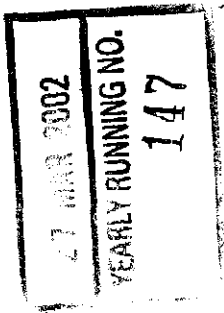

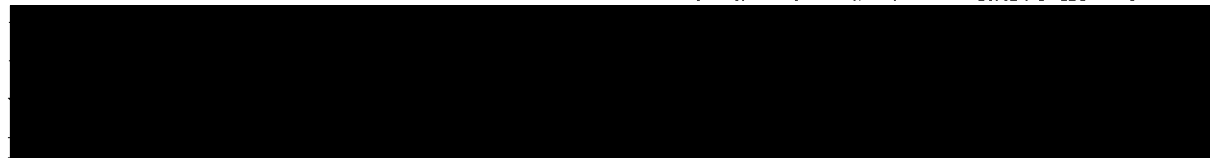

THE ANCIENT MONUMENTS AND ARCHAEOLOGICAL AREAS ACT 1979
ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as Glenbield, fort 800m ENE of comprises the remains of a fort, a defended settlement site dating from the later prehistoric "Iron Age" period. The fort lies at around 360m OD on a W-facing hillslope overlooking the valley of the Soonhope Burn. The area to be scheduled is irregular in shape, measuring a maximum of 100m E-W by 90m N-S. The W and NW boundaries of the scheduled area are defined by the edge of the forestry road. The monument, which lies in the Parish of Peebles and the County of Peebles as shown outlined in red on the Plan annexed and executed as relative hereto and



hereby included in the Schedule of Monuments appearing to the Scottish Ministers to be of national importance compiled and maintained by them under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

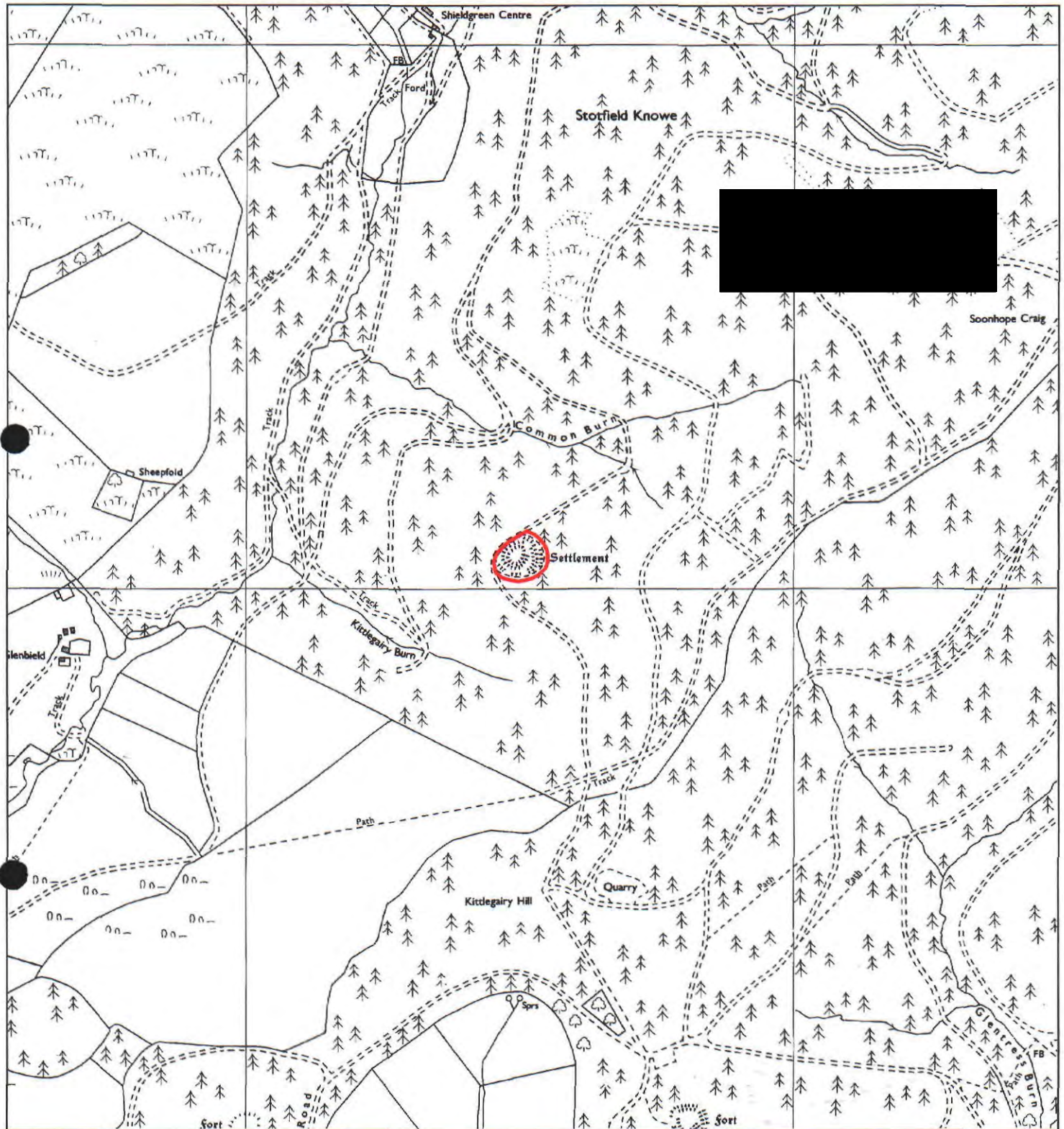

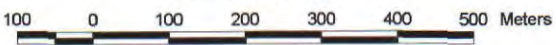
