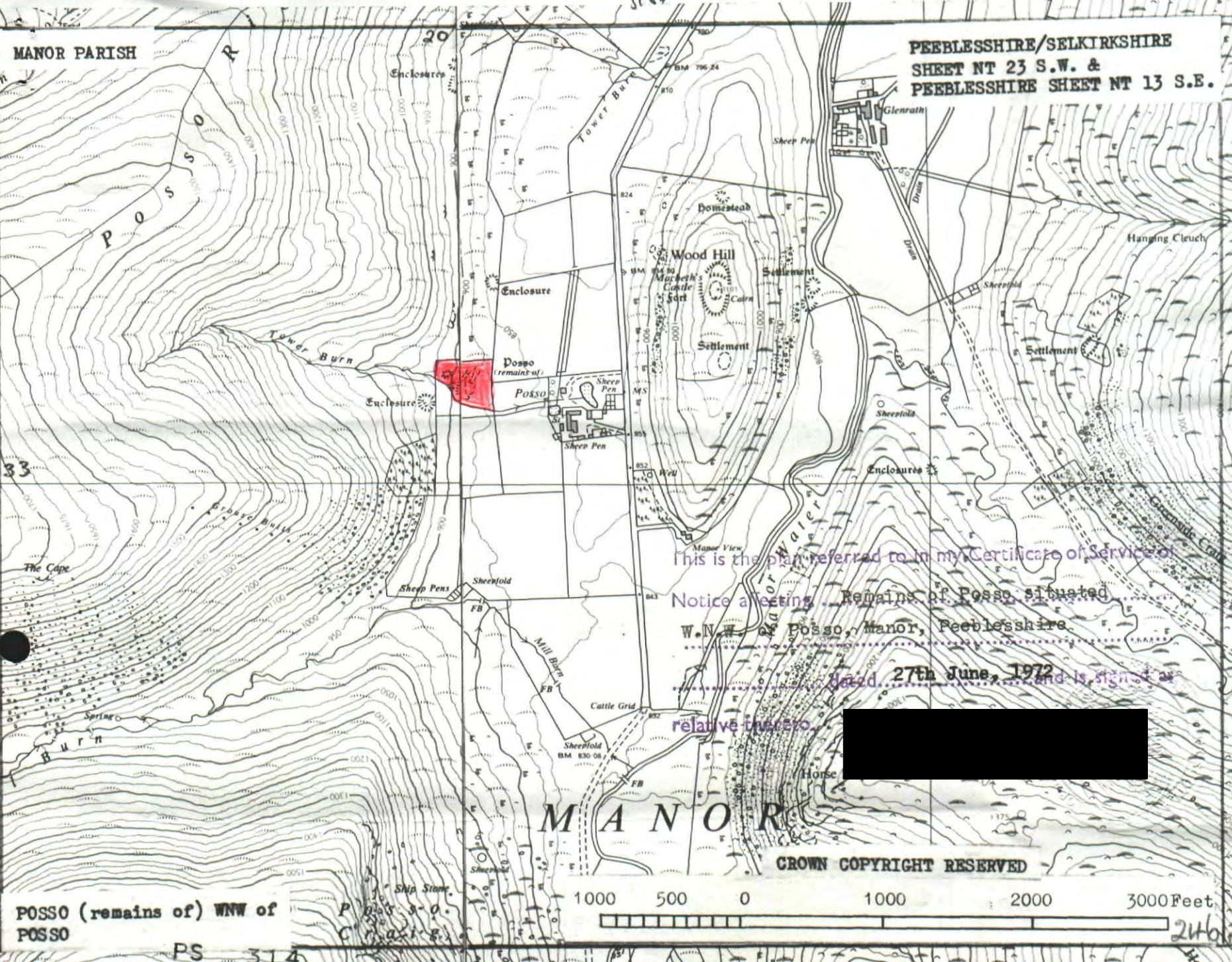

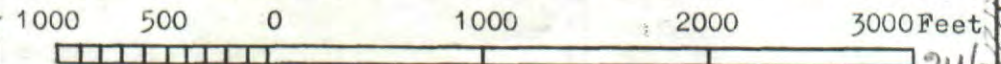
MANOR PARISH
