ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as St Kilda, Claignann an Tigh Faire, platform and cleitean comprises a prehistoric platform, presumed to be the base for a house structure, and a large and diverse range of small cleitean (small drystone buildings used for storage). It also includes the Lover's stone. The area to be scheduled is irregular on plan, and measures c.350m from NW to SE by 75m transversely. It includes the remains described and an area around them within which related material may be expected to survive. The monument, which lies in the Parish of Harris and the County of Inverness as shown outlined in red on the Plan annexed and executed as relative hereto

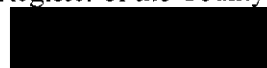

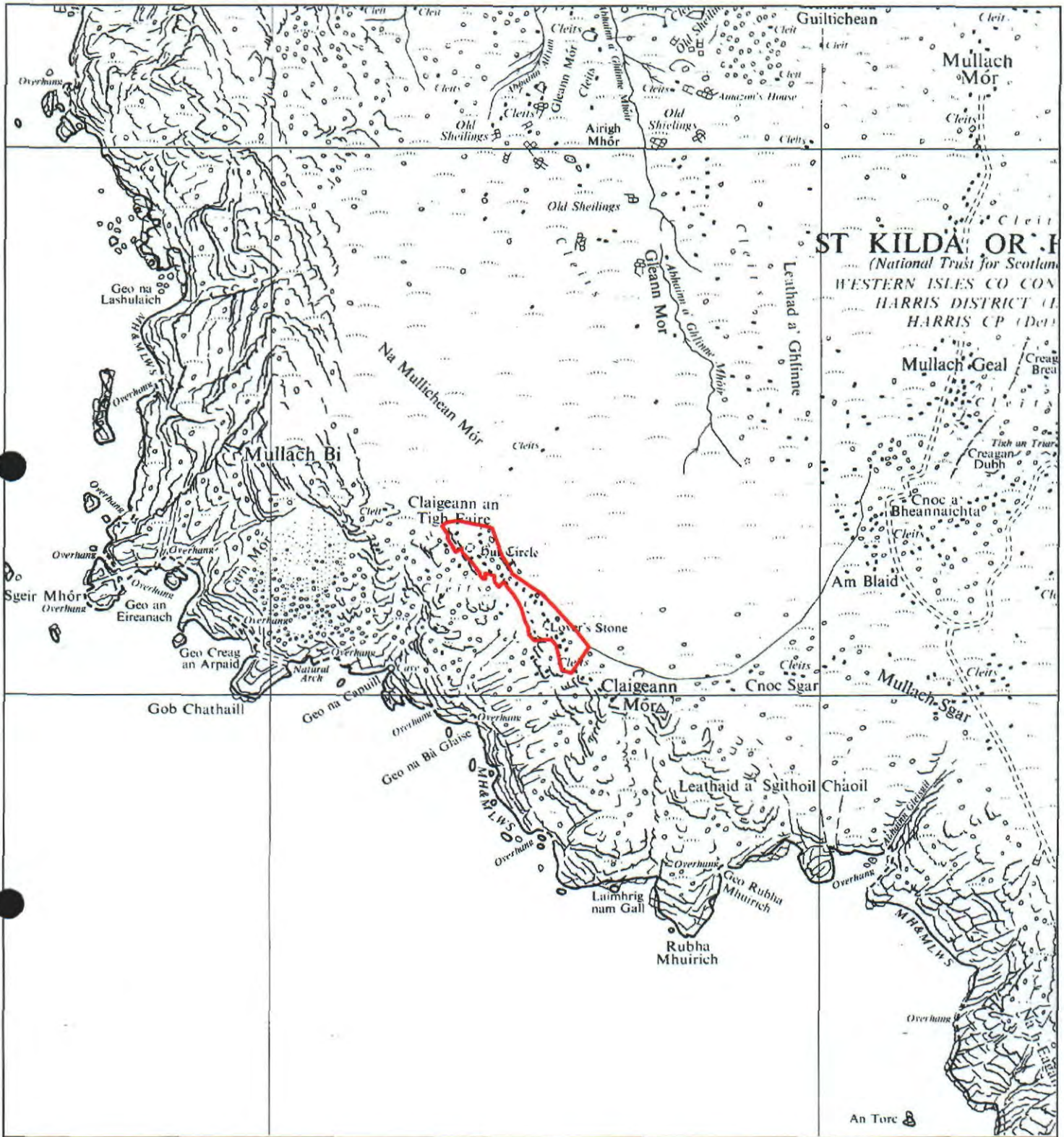


