ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as Tullos Cairn, cairn comprises the remains of a massive burial cairn of bare stones. The monument is situated on the N facing slopes of Tullos Hill, overlooking Nigg Bay, at c. 50m OD. Although greatly mutilated, it still measures approximately 20m in diameter and stands some 2m high. Another three cairns are located within close vicinity, indicating that this monument may form part of a relict prehistoric funerary landscape. The area to be scheduled is a circle of diameter 60m centred on the centre of the cairn, to include the cairn and an area around it in which evidence relating to its construction and use may survive. The monument, which lies in the Parish of Aberdeen and the County of Kincardine as shown outlined in red on the Plan annexed and executed as relative hereto



is hereby included in the Schedule of Monuments appearing to the Scottish Ministers to be of national importance compiled and maintained by them under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

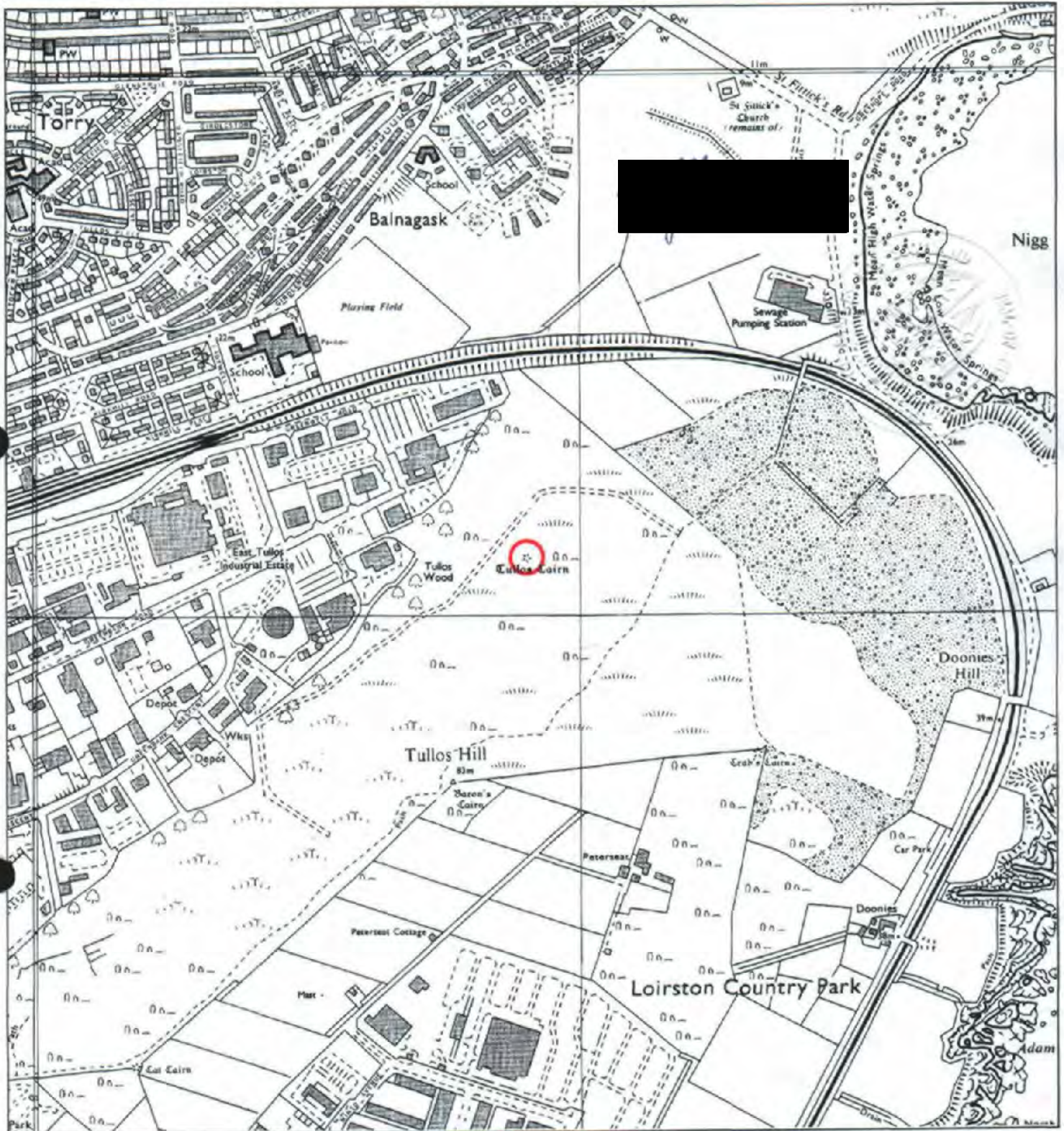
