The monument known as St Mary's Chapel and tombstones, Tobermory, comprises the foundations of a chapel and tombstones of medieval date, visible as upstanding remains. The area to be scheduled comprises the remains described and an area around them within which related material is likely to survive. It is sub-rectangular and measures 16.7m WNW-ESE by 11.5m transversely. The monument, which lies in the Parish of Kilninian and Kilmore and the County of Argyll as shown outlined in red on the Plan annexed and executed as relative hereto

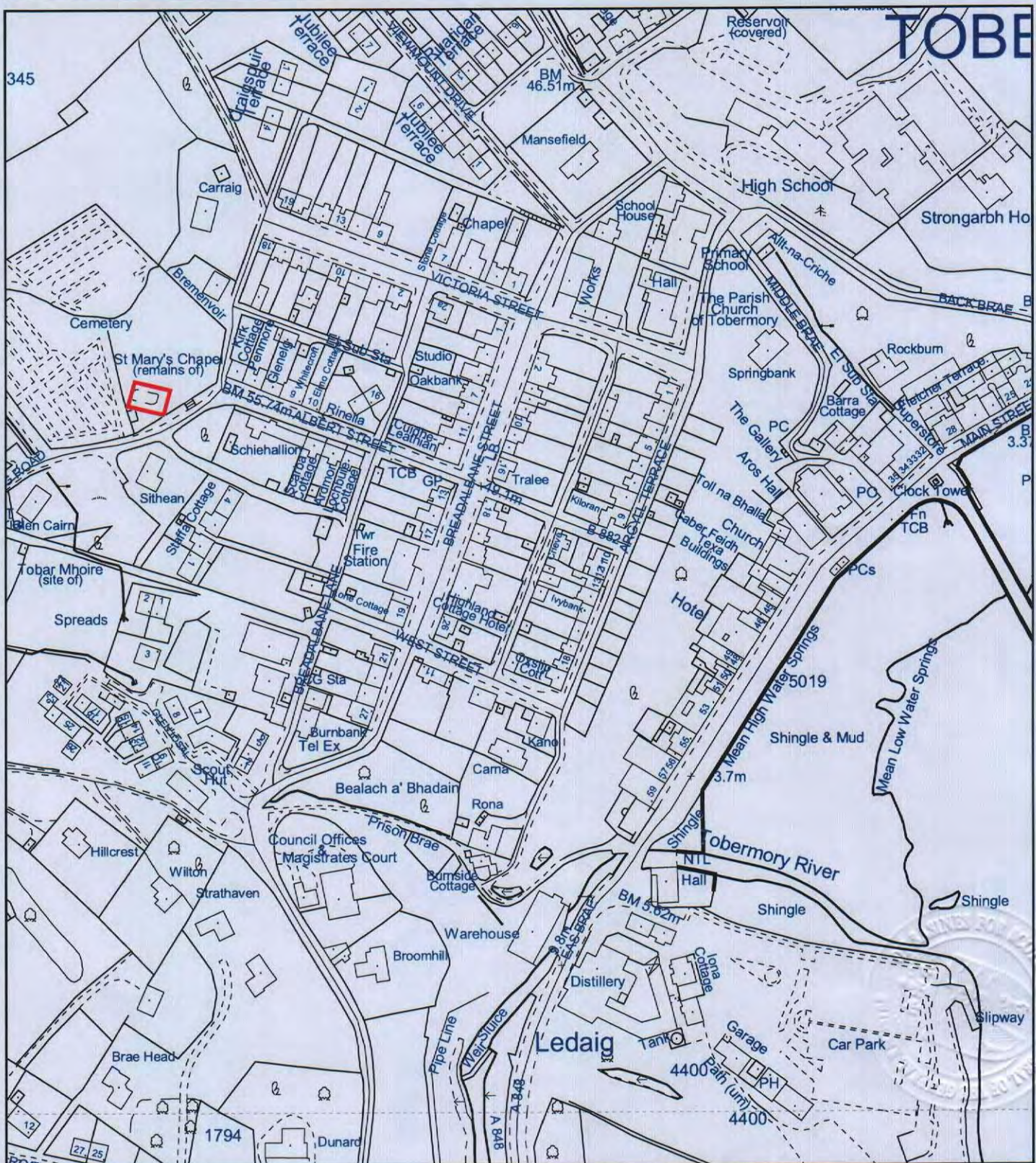
