**THE ANCIENT MONUMENTS AND ARCHAEOLOGICAL AREAS ACT 1979
ENTRY IN THE SCHEDULE OF MONUMENTS**

The monument known as Montgoldrum, cairns and hut circle 400m E of comprises the remains of at least 6 burial cairns and a hut circle on the top of Mont Goldrum Hill. The largest cairn measures 18.5m in diameter and 0.7m high. About 18m to the SW a second cairn, known as "The Camp", measures 17.8m in diameter; it has been severely robbed. To the NNE of "The Camp" is a line of 3 low cairns. A further low cairn lies immediately to the NW. The hut circle lies to the E of the cairns; it measures c10.5m in diameter, crest to crest, defined by a turf covered wall c0.2m high. The area to be scheduled measures a maximum of 135m E to W by 80m N to S, to include the cairns and the hut circle and an area around them in which traces of activity associated with their construction and use may survive; the modern fence bounding the area to the S is specifically excluded from the scheduling. The monument, which lies in the Parish of Arbuthnott and the County of Kincardine as shown outlined in red on the Plan annexed and executed as relative hereto and

[REDACTED], is hereby included in the Schedule of Monuments appearing to the Secretary of State for Scotland to be of national importance compiled and maintained by him under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

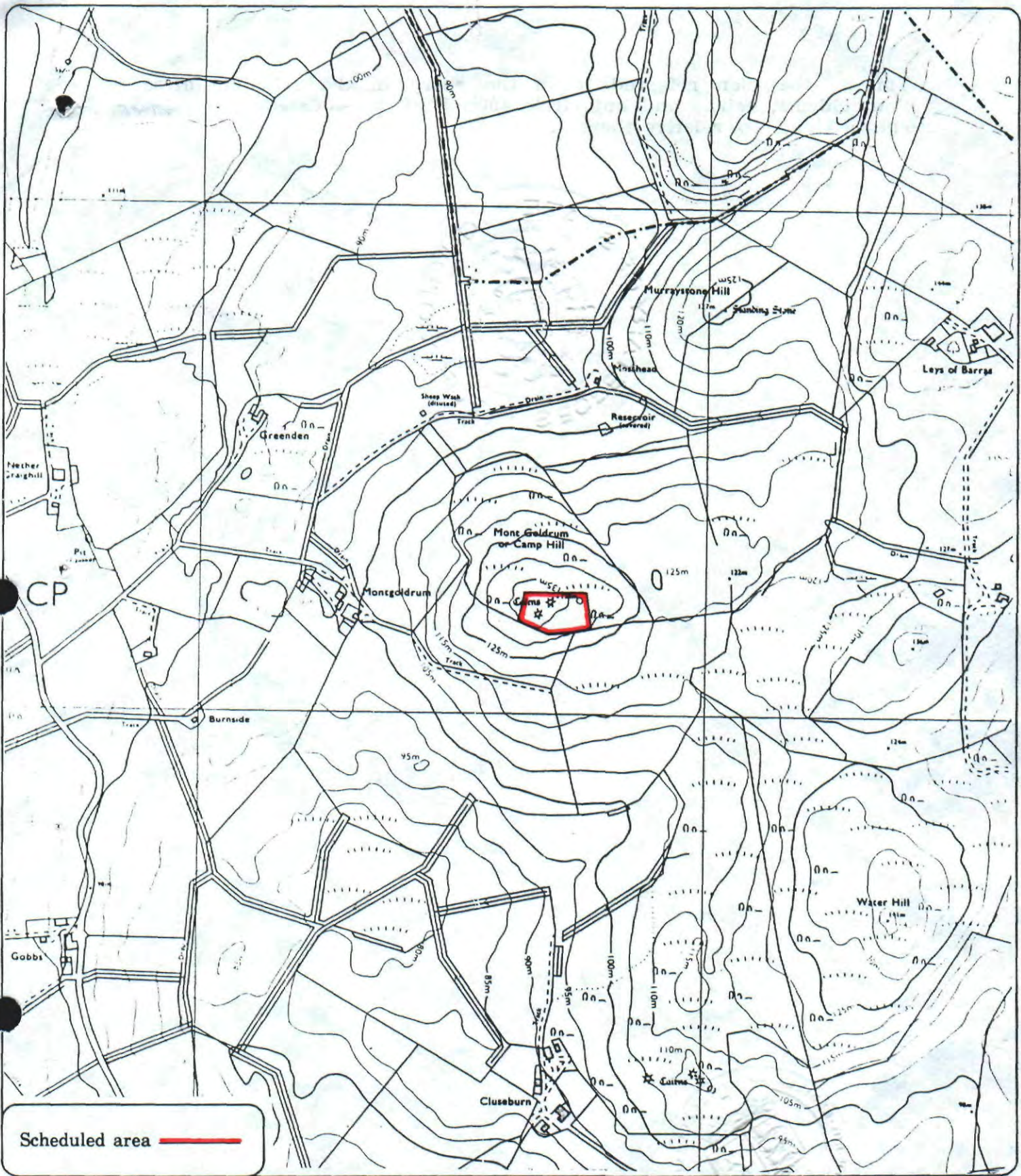

Scheduled area

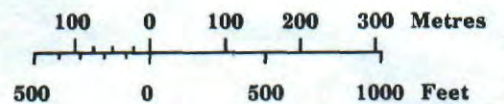
