ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as Scalavat, souterrain and settlement, Usinish comprises a souterrain beneath a ruined structure, apparently the ruins of a prehistoric settlement, and, in the area around this mound, the remains of a late-Medieval farming settlement. The area to be scheduled is irregular on plan, measuring a maximum of 170m SW-NE by 110m NW-SE, to include the souterrain, prehistoric and later settlements, shielings and field remains. The monument, which lies in the Parish of South Uist and the County of Inverness as shown outlined in red on the Plan annexed and executed as relative hereto and which forms part of the

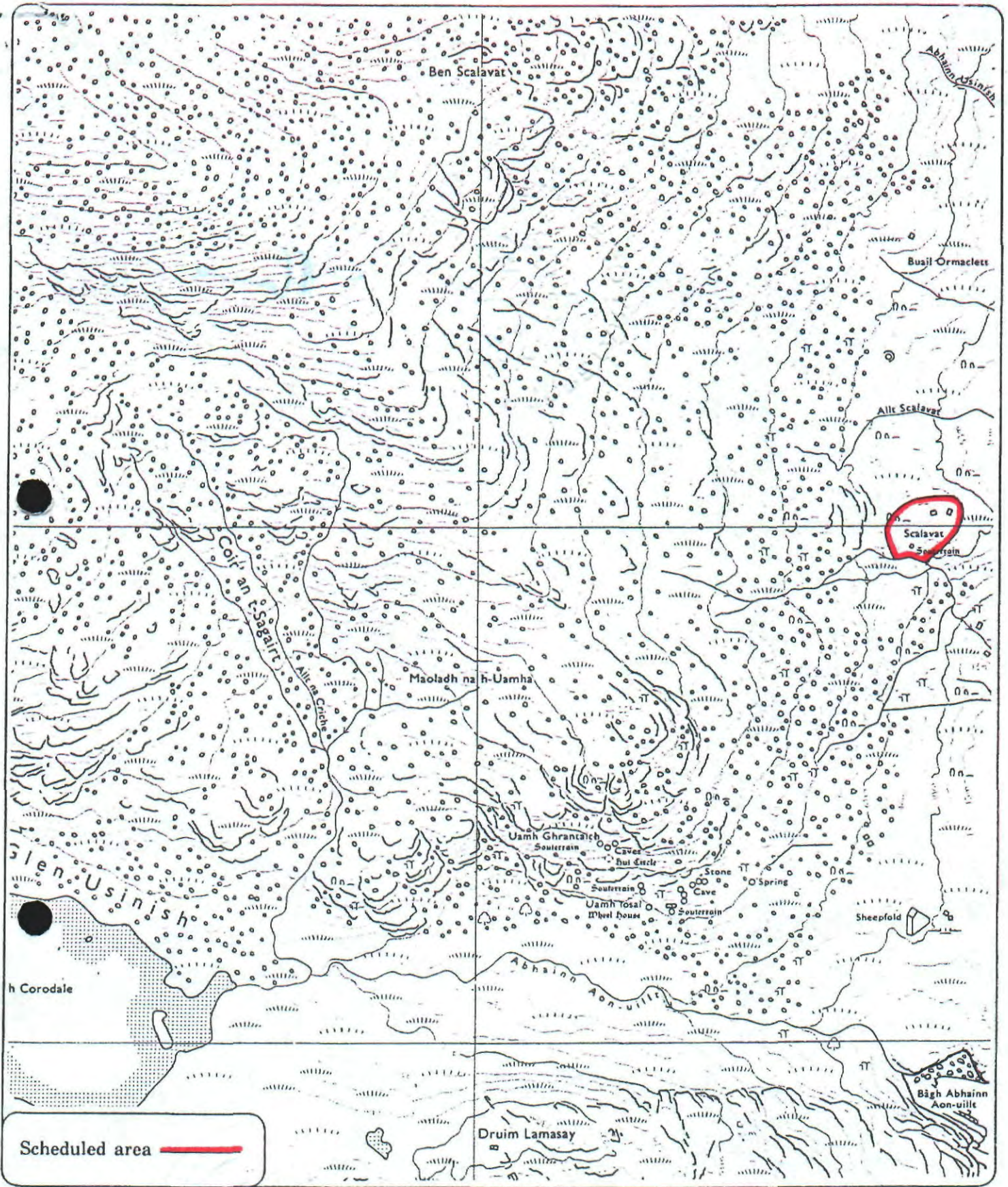





