THE ANCIENT MONUMENTS AND ARCHAEOLOGICAL AREAS ACT 1979
ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as Dun Ban, dun, Loch Huna comprises an Iron Age fortified settlement, or dun, with later settlement overlying it, on an island in the N part of Loch Huna. The area to be scheduled consists of the whole surface of the island, and a part of the loch bed to the N, to include the dun, later buildings and the S part of the causeway. It is an irregular oval, with maximum dimensions 80m NNW-SSE by 48m transversely. The monument, which lies in the Parish of North Uist and the County of Inverness as shown outlined in red on the Plan annexed and executed as relative hereto and which forms part of the subjects



is hereby included in the Schedule of Monuments appearing to the Secretary of State for Scotland to be of national importance compiled and maintained by him under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

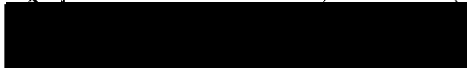

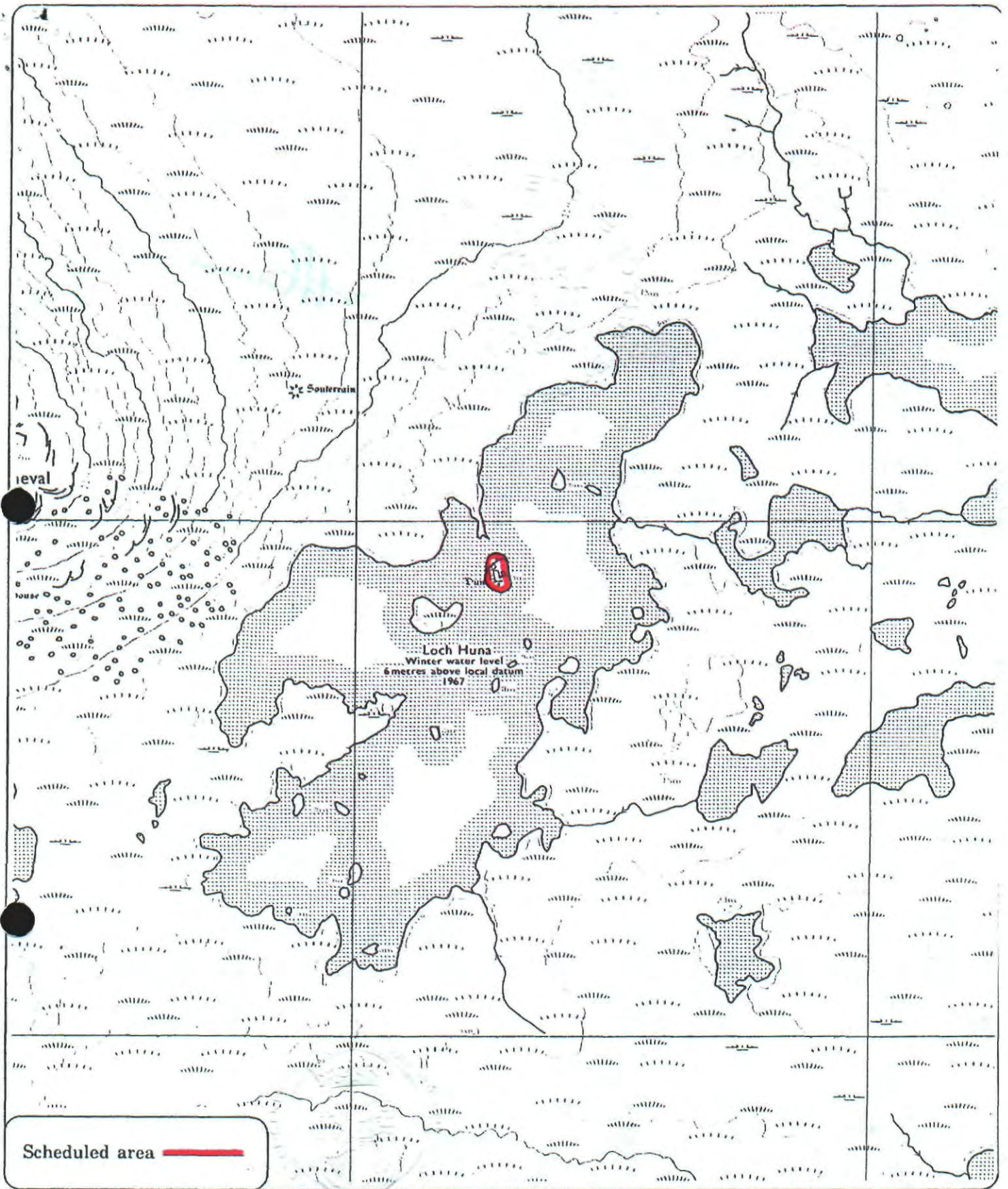


