THE ANCIENT MONUMENTS AND ARCHAEOLOGICAL AREAS ACT 1979  
ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as Gruting School, settlement and field system at head of Scutta Voe comprises the remains of a prehistoric settlement of at least four houses, with traces of field walls and field clearance cairns. The area to be scheduled is irregular on plan and in three parts: the main portion lying N of the road and two smaller areas lying S of it. The main area measures a maximum of 360m NW-SE by 140m, bounded on the S by the N edge of the modern road, and the two smaller areas are a maximum of 70m WNW-ESE by 25m around the garage on the second house site (the above-ground structure of the garage is excluded) and a maximum of 90m NW-SE by 35m at the S extremity of the larger area. Both smaller areas are bounded on the N by the S edge of the road. The monument, which lies in the Parish of Sandsting and the County of Shetland as shown outlined in red on the Plan annexed and executed as relative hereto



is hereby included in the Schedule of Monuments appearing to the Secretary of State for Scotland to be of national importance compiled and maintained by him under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

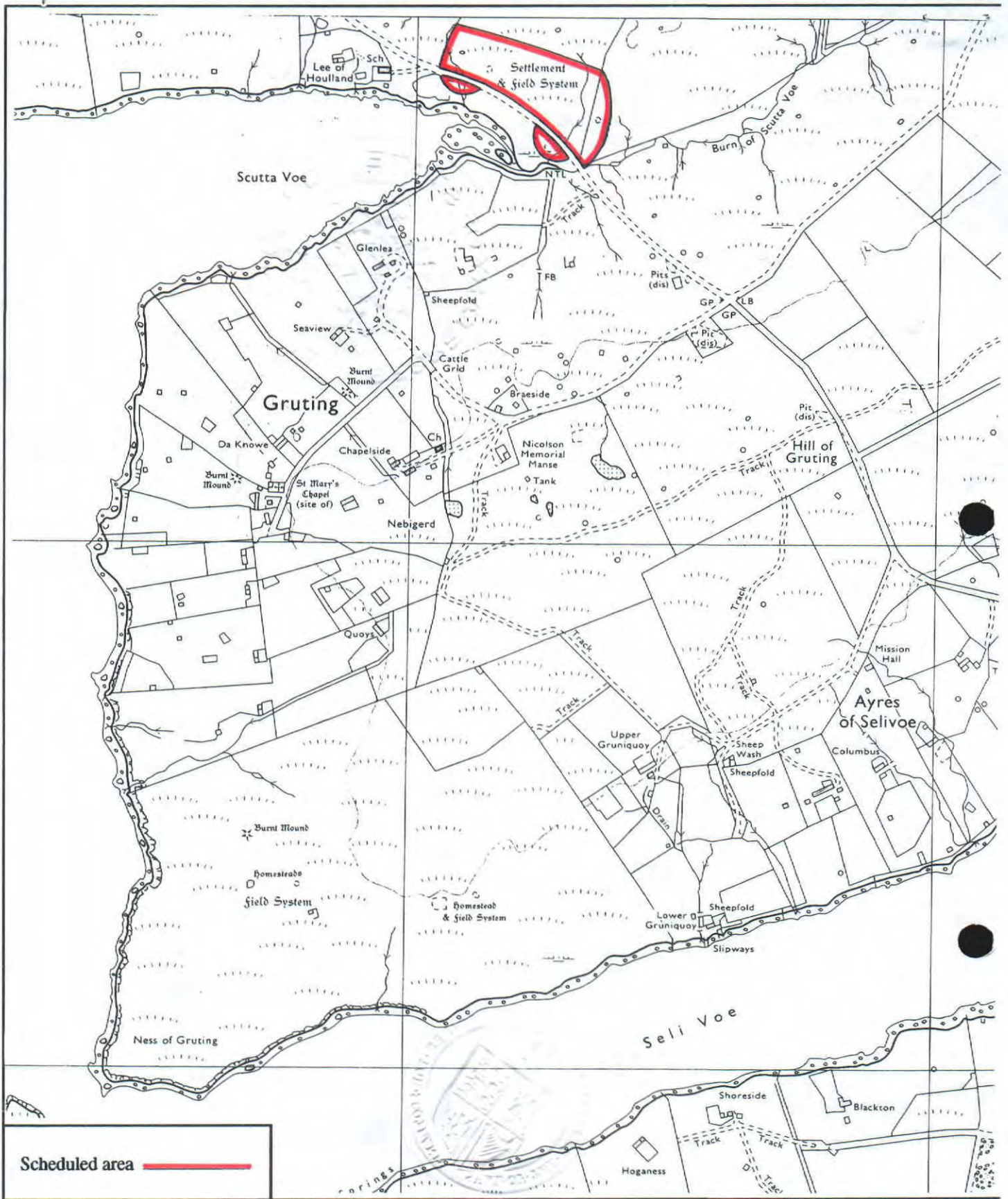
