ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as Wallace's Cave, cave and rock carvings, comprises an artificial cave of unknown date, popularly known as 'Wallace's Cave', and a series of rock carvings of prehistoric date in a nearby recess or shelter. The areas to be scheduled include the cave and the carvings respectively, and an area around each of them in which traces of associated activity is likely to survive. The first area includes Wallace's Cave and the approach to its entrance, and has maximum dimensions of 25m N-S by 13m W-E; the second area includes the rock shelf on which is the recess containing the rock carvings and has maximum dimensions of 30m N-S by 8m E-W. The monument, which lies in the Parish of Lasswade and the County of Midlothian as shown outlined in red on the Plan annexed and executed as relative hereto

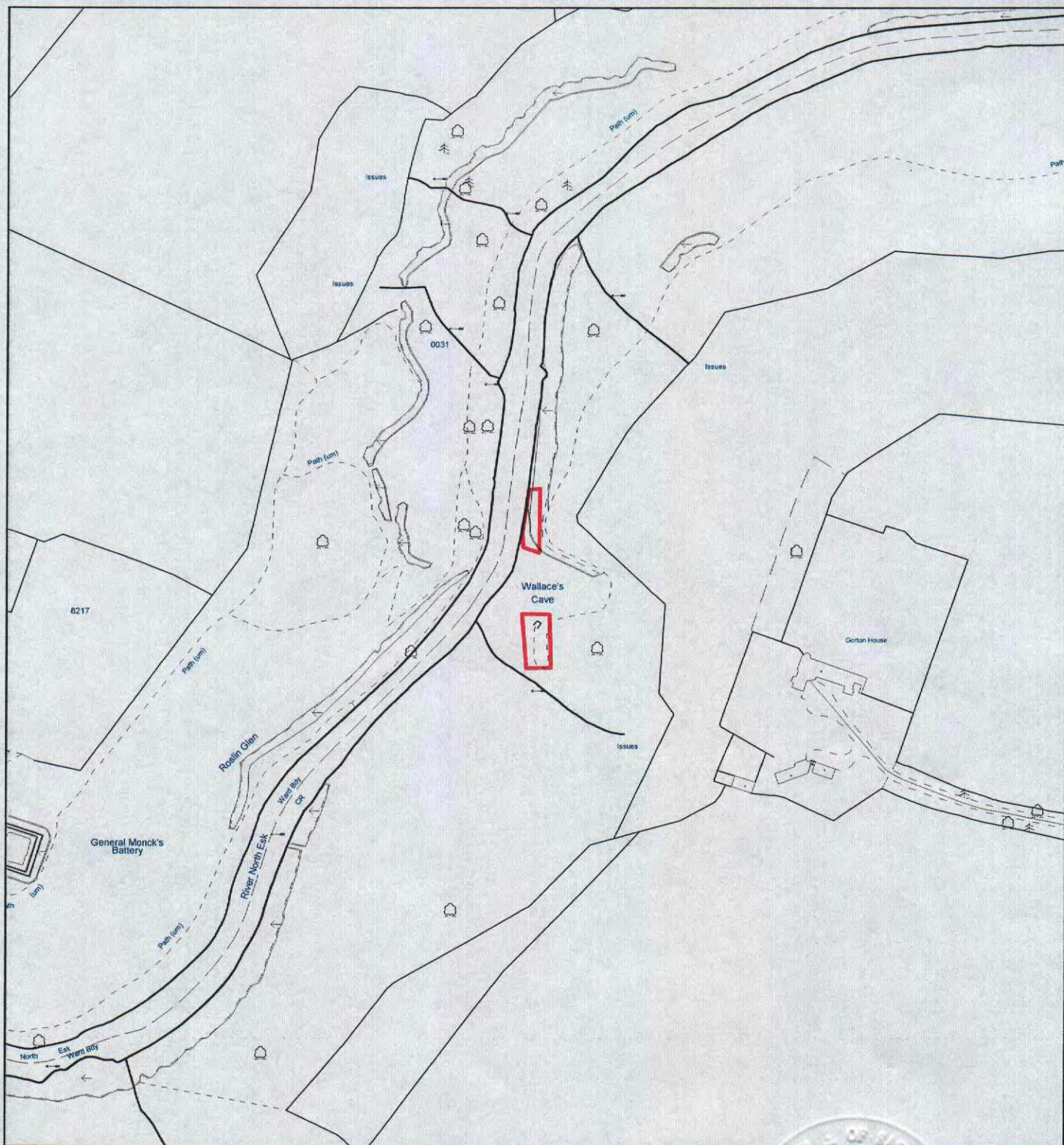
