ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as Inner Skaw, houses and field system, Unst comprises the remains of a series of farmhouses, the earliest of which may be of early Norse date, and a nearby series of abandoned fields of various dates and forms which would have been associated with different phases of the farming settlement. The area to be scheduled is irregular on plan, with maximum dimensions of 260m E-W by 250m N-S, to include the settlement site, its adjoining fields and the area of old fields stretching across to the top of the slope opposite. It runs to the top of coastal cliffs at the N and on the S is partly bounded by a line running just N of a modern fence. All modern fences are excluded from scheduling to simplify maintenance. The monument, which lies in the Parish of Unst and the County of Shetland as shown outlined in red on the Plan annexed and executed as relative hereto and

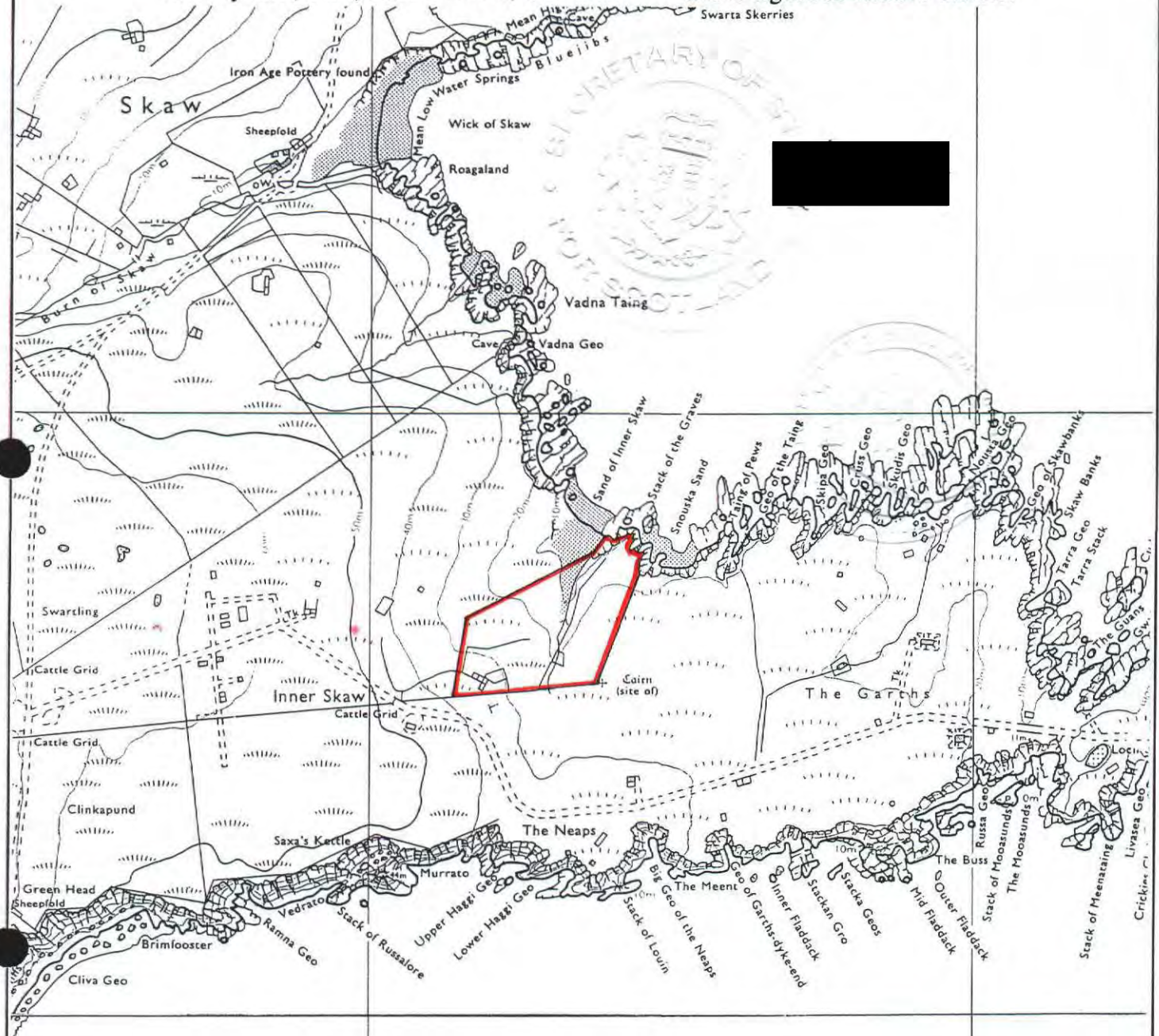

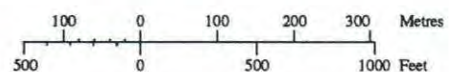
