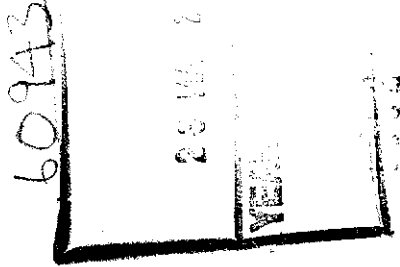

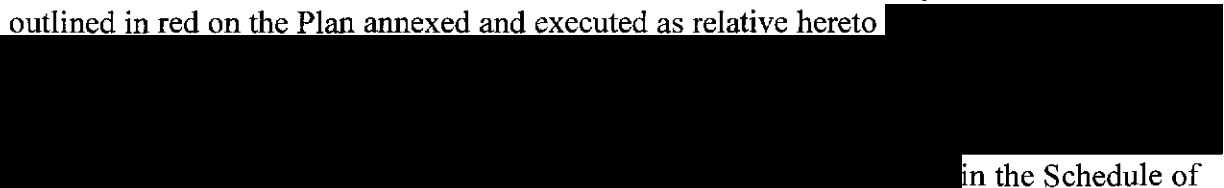

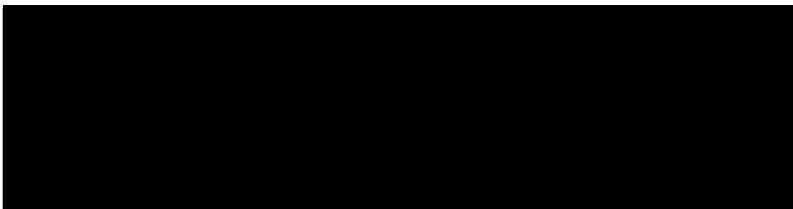
THE ANCIENT MONUMENTS AND ARCHAEOLOGICAL AREAS ACT 1979  
ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as Haugh of Aberuthven, standing stone, enclosure and ring-ditch SW of comprises a standing stone, enclosure and ring-ditch of prehistoric date. The enclosure and ring-ditch are visible as cropmarks on oblique aerial photographs. The standing stone probably relates to ritual activity of Neolithic date. The area to be scheduled comprises the remains described and an area around them within which related material may be expected to be found. It is irregular, with maximum dimensions of 110m from its N-most point to its S-most point and 100m from its E-most point to its W-most point. The monument, which lies in the Parish of Auchterarder and the County of Perth as shown outlined in red on the Plan annexed and executed as relative hereto




in the Schedule of Monuments appearing to the Scottish Ministers to be of national importance compiled and maintained by them under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

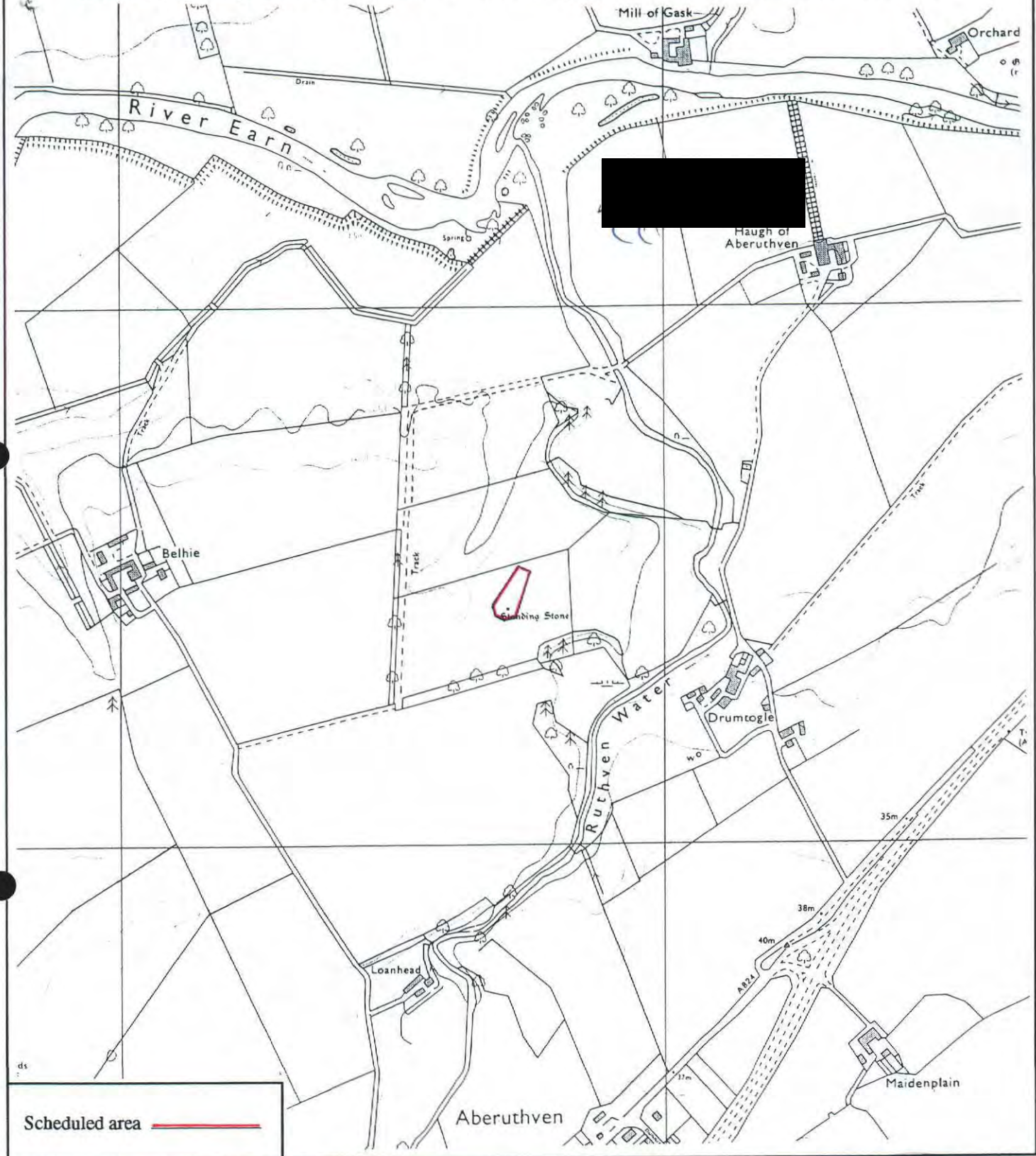


