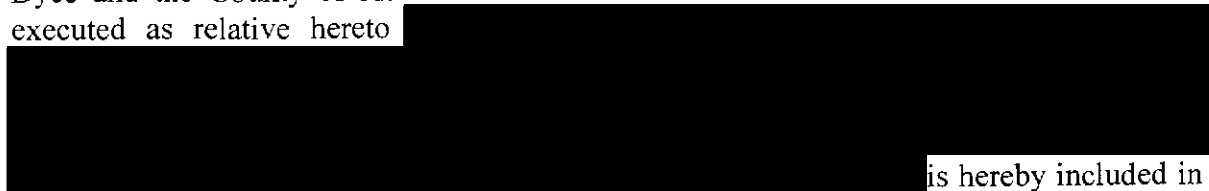

ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as The Slacks, Kirkhill Forest, burial cairn, hut circles and cairnfield comprises a circular burial cairn, three certain hut circles, a further four possible hut circles and a cairnfield, all surviving within woodland as upstanding monuments. The area to be scheduled is irregular in shape, with maximum dimensions of about 470m SW-NE by 370m W-E. It includes the visible upstanding monuments and an area around them within which related remains might be expected to survive. The monument, which lies in the Parish of Dyce and the County of Aberdeen as shown outlined in red on the Plan annexed and executed as relative hereto



is hereby included in the Schedule of Monuments appearing to the Scottish Ministers to be of national importance compiled and maintained by them under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

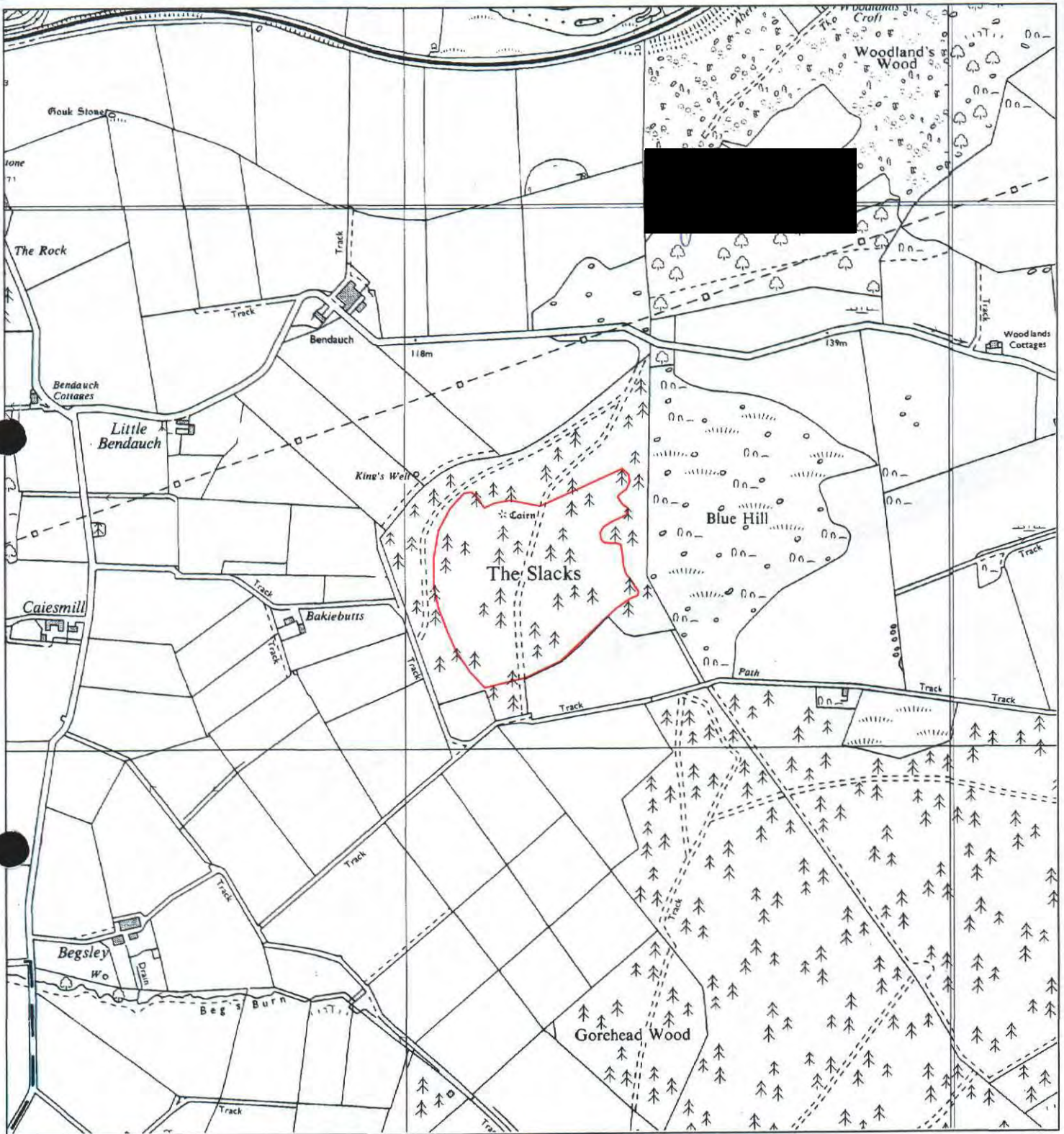
