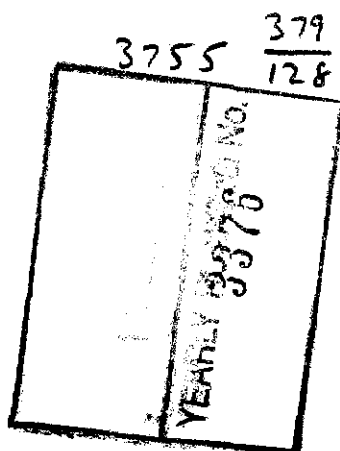

ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as Bridge on Old Military Road over Delavine Burn comprises the remains of a small mid-18th century bridge over the Delavine Burn on the line of the Old Military Road connecting Coupar Angus to Fort George. The road was built to connect Perth and Dundee with the, then newly built Fort George. The small single-arched bridge over the Delavine Burn is typical of bridge building associated with the military roads. The area to be scheduled is rectangular, and includes the bridge and an area around it in which traces of activities associated with the construction and use of the monument may survive. The area has maximum dimensions of 25m E-W by 7m transversely. The roadway, which is still used as an estate road, now bypasses the bridge. The monument, which lies in the Parish of Strathdon and the County of Aberdeen as shown outlined in red on the Plan annexed and executed as relative hereto and which forms part of the lands of

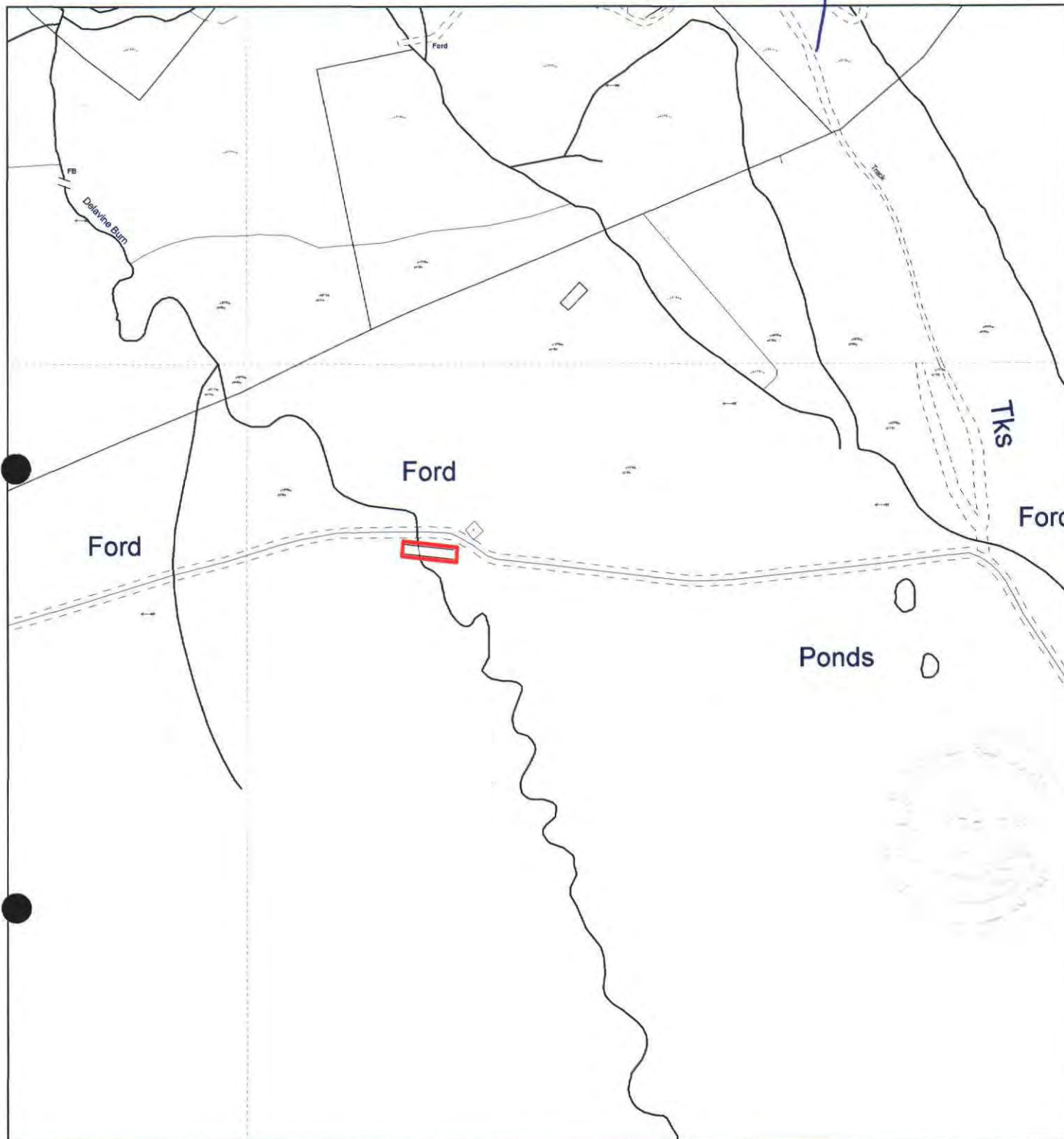
