ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as Balnagask motte, Baxter Place, Aberdeen comprises a motte of medieval date, visible as a substantial grass-covered mound. The area to be scheduled comprises the remains described and an area around them within which related material may be expected to survive. It is irregular in shape, with maximum dimensions of 74m NNW-SSE by 54m WSW-ENE. It is confined within the existing high boundary wall around the NE, E and S edges of the site, and a wooden fence around the NW and W. The boundary walls and fences are excluded from the scheduling to allow for routine maintenance. The monument, which lies in the Parish of Aberdeen and the County of Aberdeen as shown outlined in red on the Plan annexed and executed as relative hereto

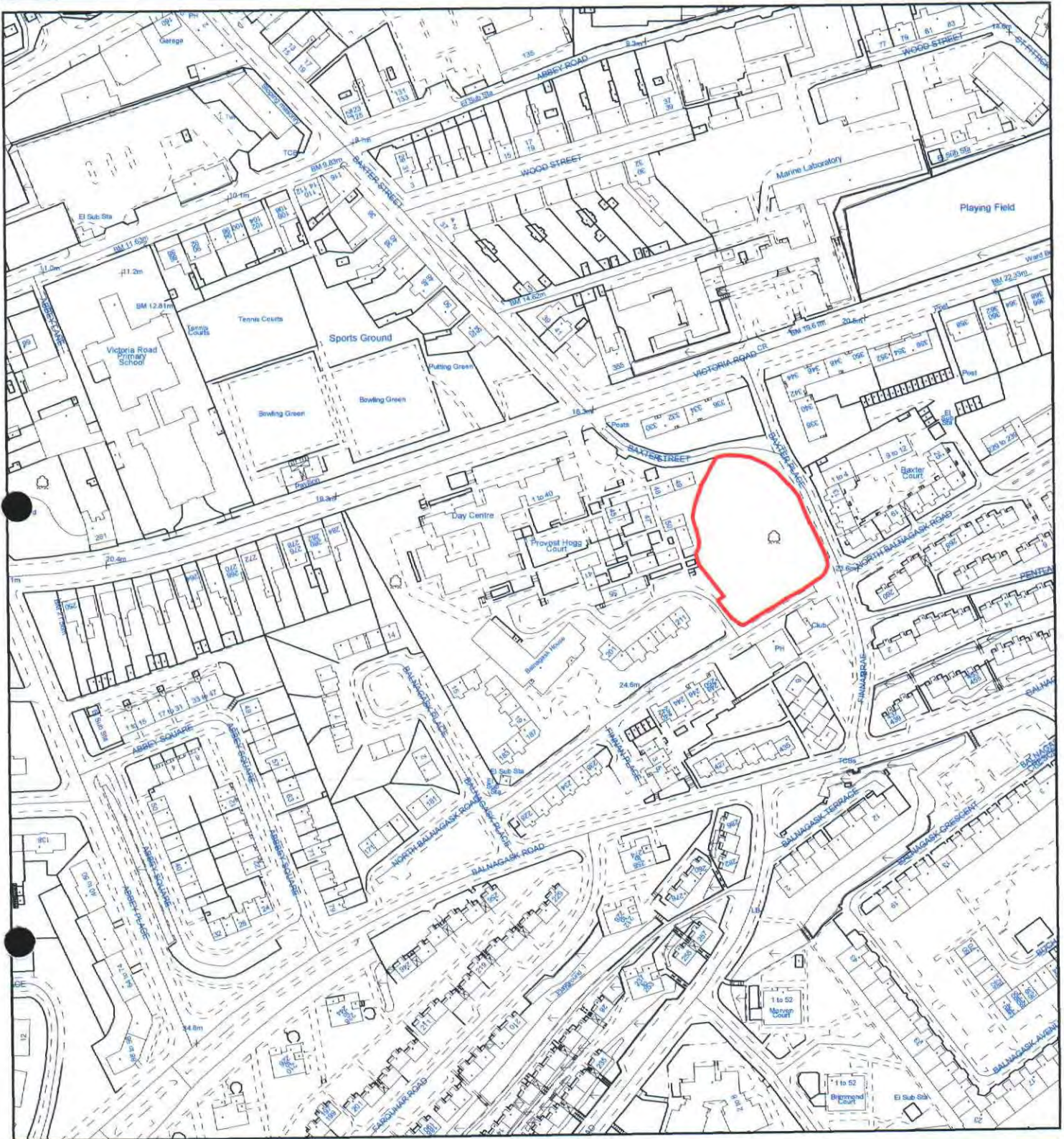
