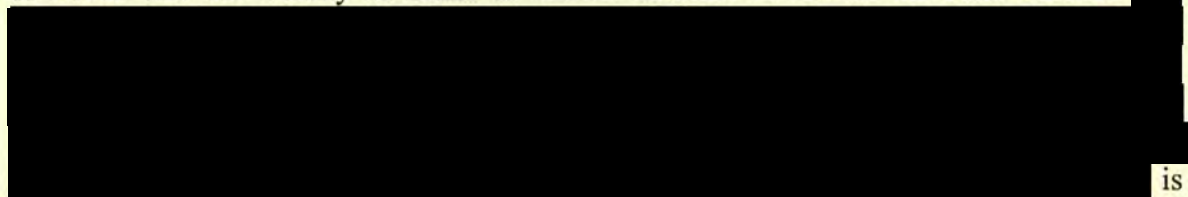


THE ANCIENT MONUMENTS AND ARCHAEOLOGICAL AREAS ACT 1979
ENTRY IN THE SCHEDULE OF MONUMENTS

11035

The monument known as Stirling Cairn, cairn 750m SW of Mill of Alvah, comprises the remains of a pre-historic burial cairn, visible as an upstanding earth and stone mound. Cairns such as this are funerary and ritual monuments built during the Neolithic period (c.3500-2500BC). The area to be scheduled comprises the remains described and an area around them within which related material may be expected to be found. It is irregular, measuring a maximum of 85m N-S by 40m E-W. The monument, which lies in the Parish of Alvah and the County of Banff as shown outlined in red on the Plan annexed

 is hereby included in the Schedule of Monuments appearing to the Scottish Ministers to be of national importance compiled and maintained by them under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

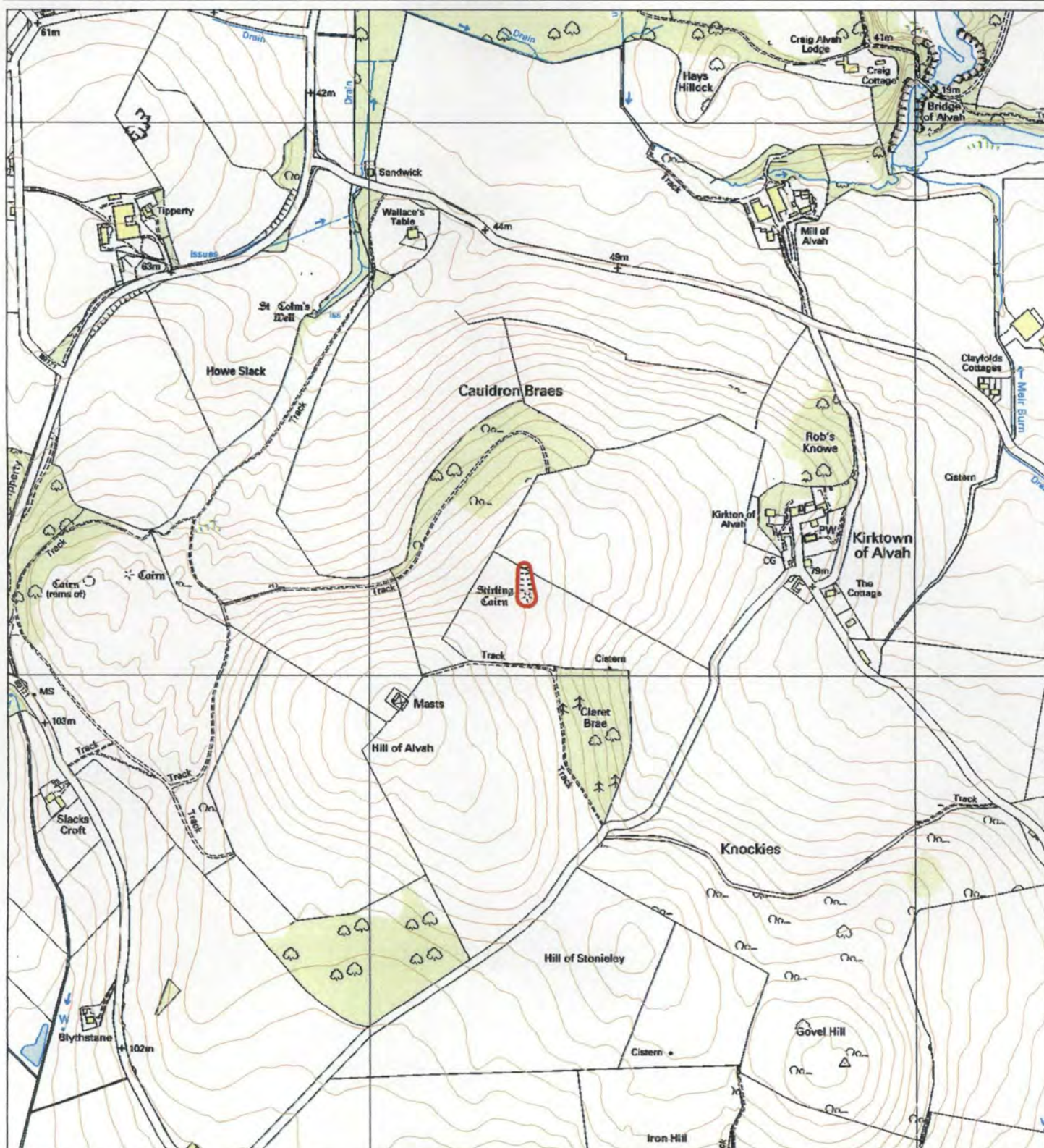
