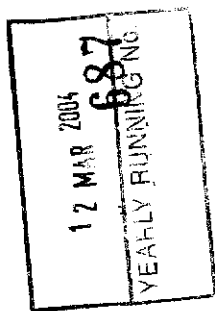

The monument known as St Peter's Church, Pabay Mor, Lewis, comprises the remains of a small church dedicated to St Peter on Pabay Mor. The surviving fabric is medieval in date but the Pabay place-name would suggest that there has been an early medieval church somewhere on the island. The area to be scheduled is a circle 40m in diameter, centred on the church, to include the church, graveyard and at least part of the settlement mound and an area around in which evidence for their construction and use may survive. The monument, which lies in the Parish of Uig and the County of Ross and Cromarty as shown outlined in red on the Plan annexed and executed as relative hereto



included in the Schedule of Monuments appearing to the Scottish Ministers to be of national importance compiled and maintained by them under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

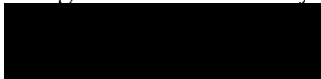

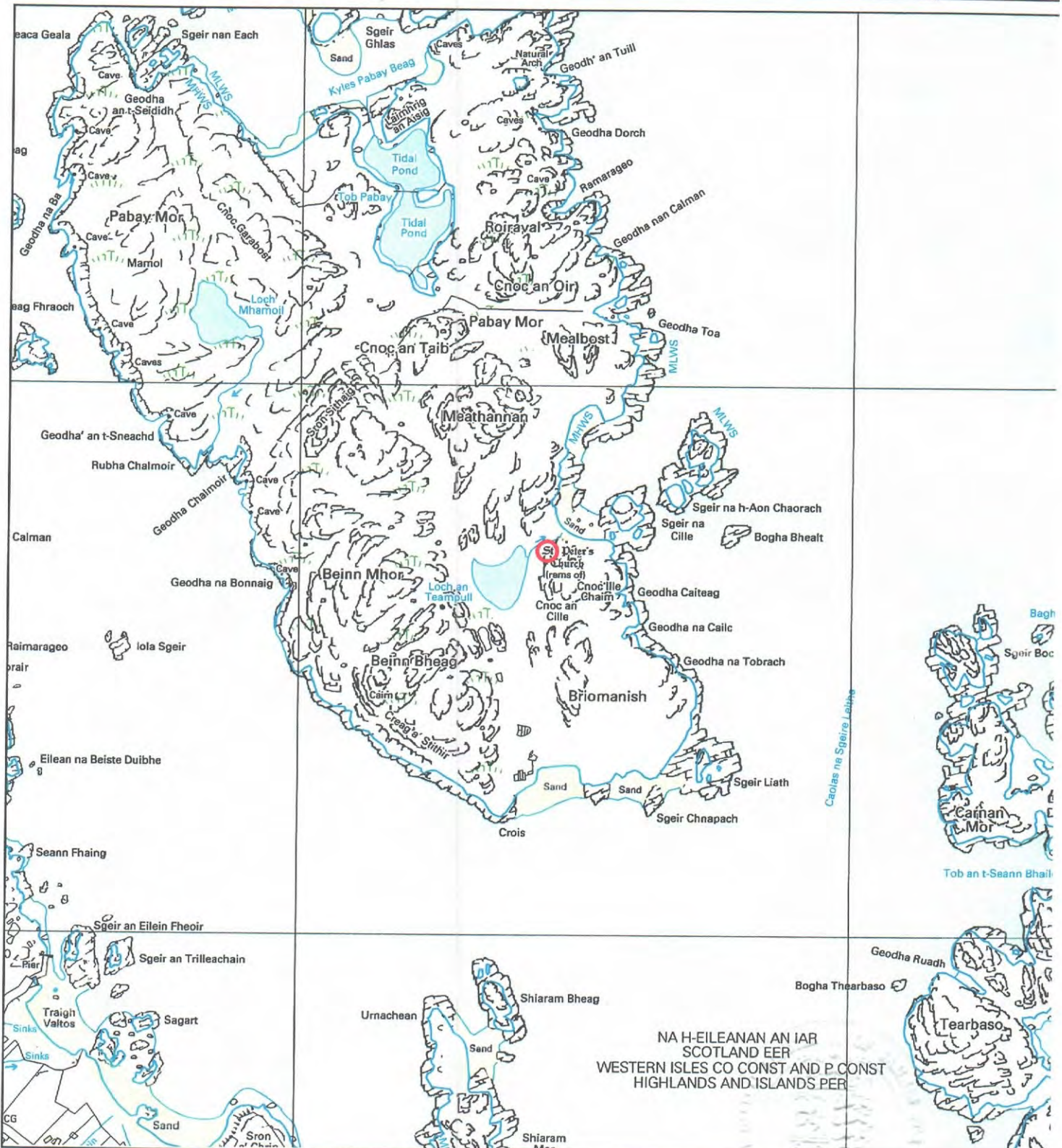
