The monument known as Scotsmill, enclosure 150m WNW of, comprises the ploughed-down remains of a ditched enclosure, within which are the remains of a building, visible as a cropmark on aerial photographs, situated in a gently-sloping field. The area to be scheduled is a circle 45m in diameter, centred on the enclosure, to include the enclosure and an area around in which features associated with its construction and use are likely to survive. The monument, which lies in the Parish of Fordyce and the County of Banff as shown outlined in red on the Plan annexed and executed as relative hereto and which forms

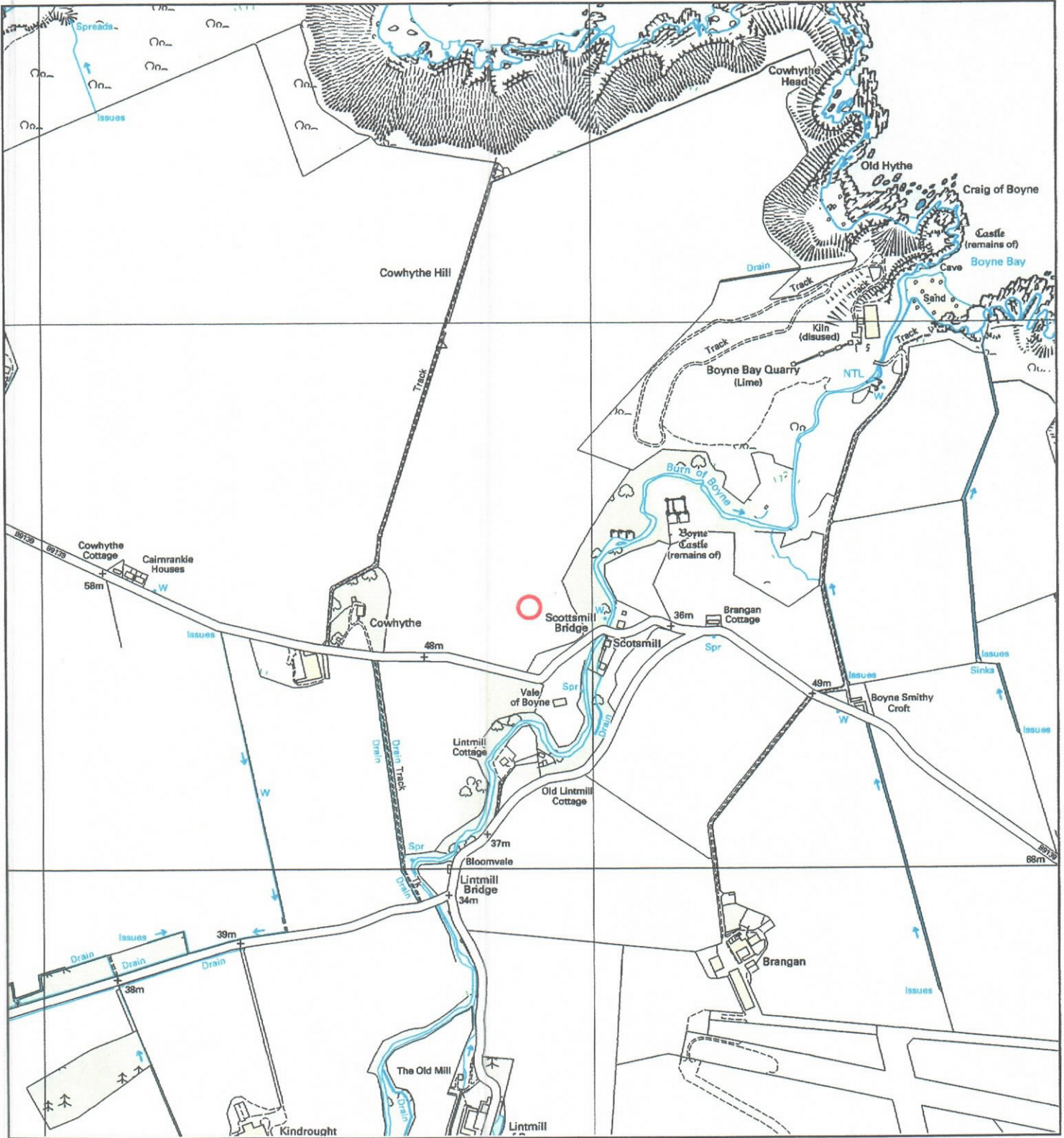
