The monument known as Gallows Hill, the Hanging Stone, standing stone, comprises a standing stone of prehistoric date, visible as an upstanding monument. The area to be scheduled comprises the standing stone and an area around it within which related material may be expected to be found. It is irregular, with maximum dimensions of 3.5m N-S by 2.5m E-W. The monument, which lies in the Parish of Pitsligo and the County of Aberdeen as shown outlined in red on the Plan annexed and executed as relative hereto

 is hereby included in the Schedule of Monuments appearing to the Scottish Ministers to be of national importance compiled and maintained by them under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

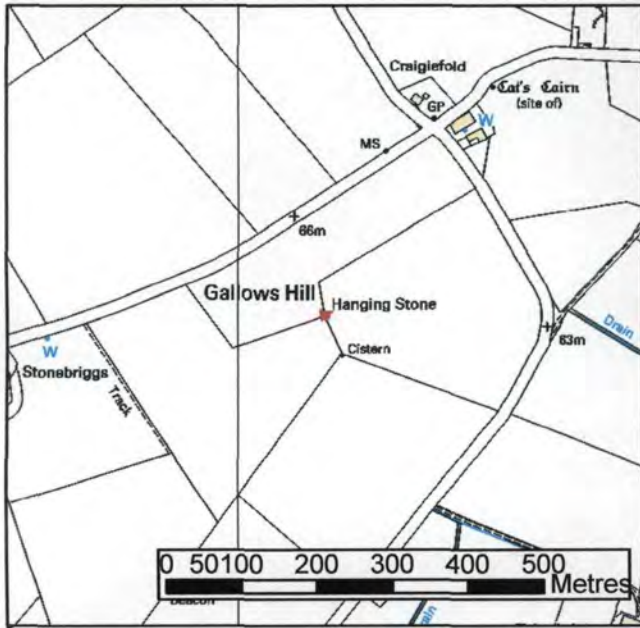

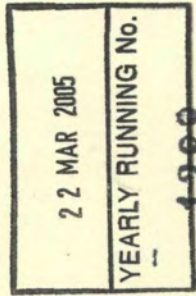
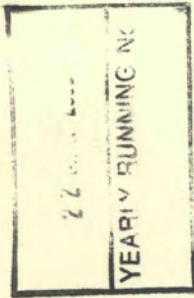
