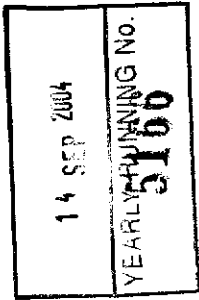

The monument known as Trefor Hill, motte, comprises a motte (an artificial castle mound) of Medieval date, visible as a grass-covered mound. The area to be scheduled comprises the remains described and an area around them within which related material may be expected to be found. It is irregular, with maximum dimensions of 35m NW-SE by 33m transversely. It is defined on the northern and eastern sides by the modern fence, and on the western side by the stone field boundary, all of which are themselves excluded from the scheduling. The monument, which lies in the Parish of Rathen and the County of Aberdeen as shown outlined in red on the Plan annexed and executed as relative hereto

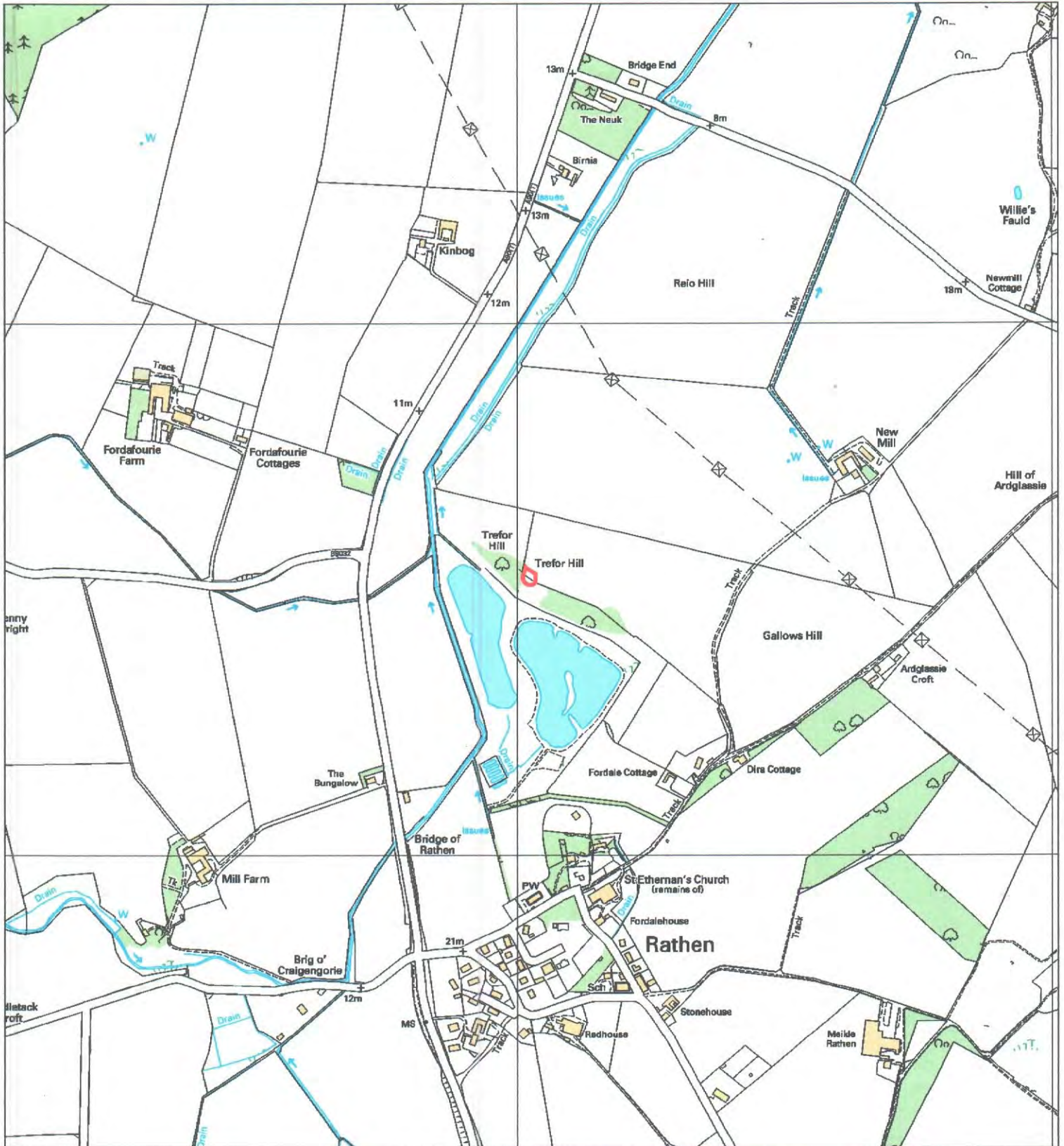
