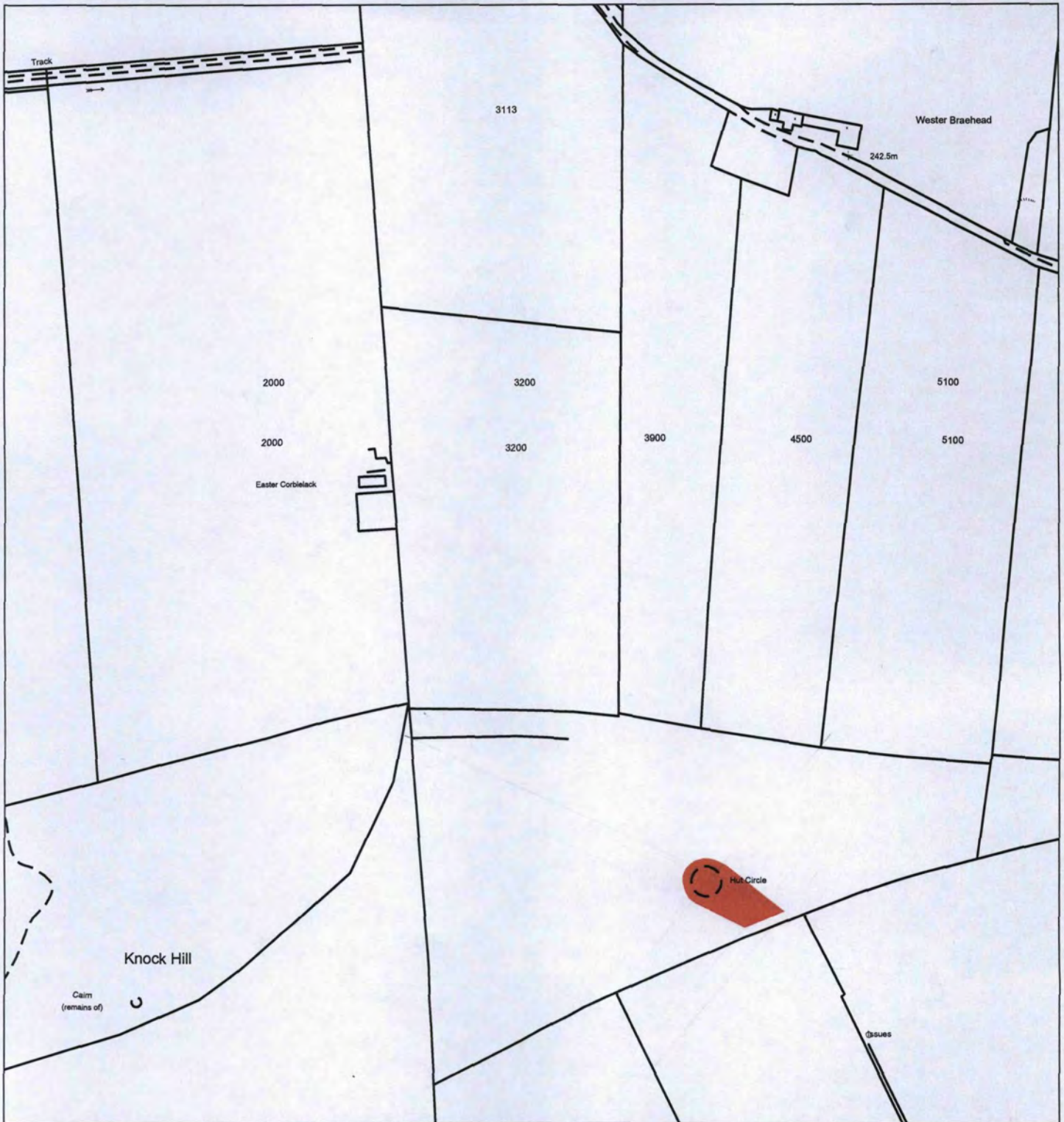

The monument known as Knock Hill, hut circle 340m S of Wester Braehead, comprises a hut circle, the footings of a prehistoric house between 2000 and 3000 years old. It lies in rough pasture on the E slopes of Knock Hill, within a group of prehistoric burial cairns, hut circles, field clearance cairns and relic field boundaries identified on Knock Hill and the environs. The area to be scheduled is polygonal, to include the hut circle and bank and an area around them in which evidence relating to their construction and use may survive. The monument, which lies in the Parish of Logie Coldstone and the County of Aberdeen as shown outlined in red on the Plan annexed and executed as relative hereto [REDACTED]
