The monument known as Gallows Hill Cairn, 460m SSE of Mains of Lesmoir, comprises a burial mound that lies in a stony, semi-improved pasture on the NE flank of The Peirk, 460m SSE of Mains of Lesmoir. The mound is made of earth and stone, and measures 20m in diameter and approximately 2m in height. The area to be scheduled is circular, centred on the cairn, to include the barrow and an area of ground around within which evidence for its construction and use can be expected to survive. The monument, which lies in the Parish of Rhynie and the County of Aberdeen as shown outlined in red on the Plan annexed and executed as relative hereto



hereby included in the Schedule of Monuments appearing to the Scottish Ministers to be of national importance compiled and maintained by them under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.
