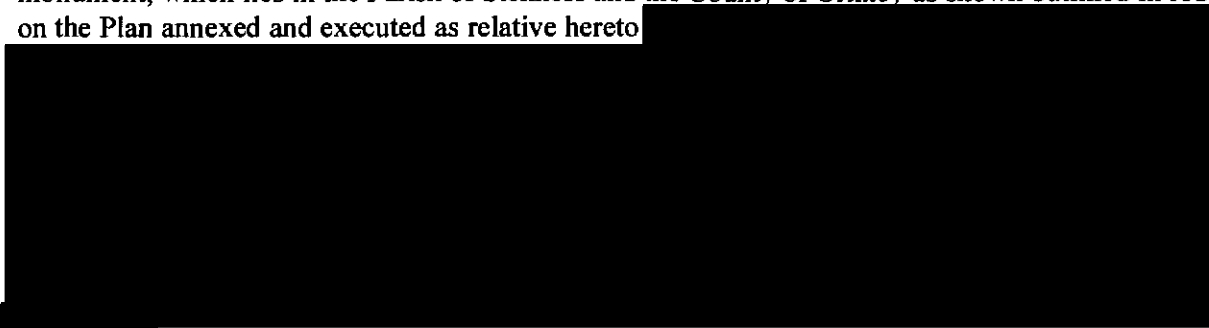

THE ANCIENT MONUMENTS AND ARCHAEOLOGICAL AREAS ACT 1979
ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as Ring of Brogar, stone circle, henge and nearby remains comprises all remains within the area in the care of the Secretary of State for Scotland at and around Ring of Brogar including a stone circle and a ditched enclosure (a henge) known together as the Ring of Brogar, four large burial mounds including Fresh Knowe, Salt Knowe and Plumcake Mound, up to a dozen small burial mounds and a stone setting including the Comet Stone on a platform, together with all artificial remains within the area around and between the visible monuments. The area to be scheduled is the area owned by the Secretary of State for Scotland, measuring 345.5m or thereabouts on its SW side, 366.5m or thereabouts on its NW side and 425m or thereabouts on its SE side and bounded on the NE by the edge of the Loch of Harray and elsewhere by a fence. The monument, which lies in the Parish of Stenness and the County of Orkney as shown outlined in red on the Plan annexed and executed as relative hereto



is hereby included in the Schedule of Monuments appearing to the Secretary of State for Scotland to be of national importance compiled and maintained by him under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

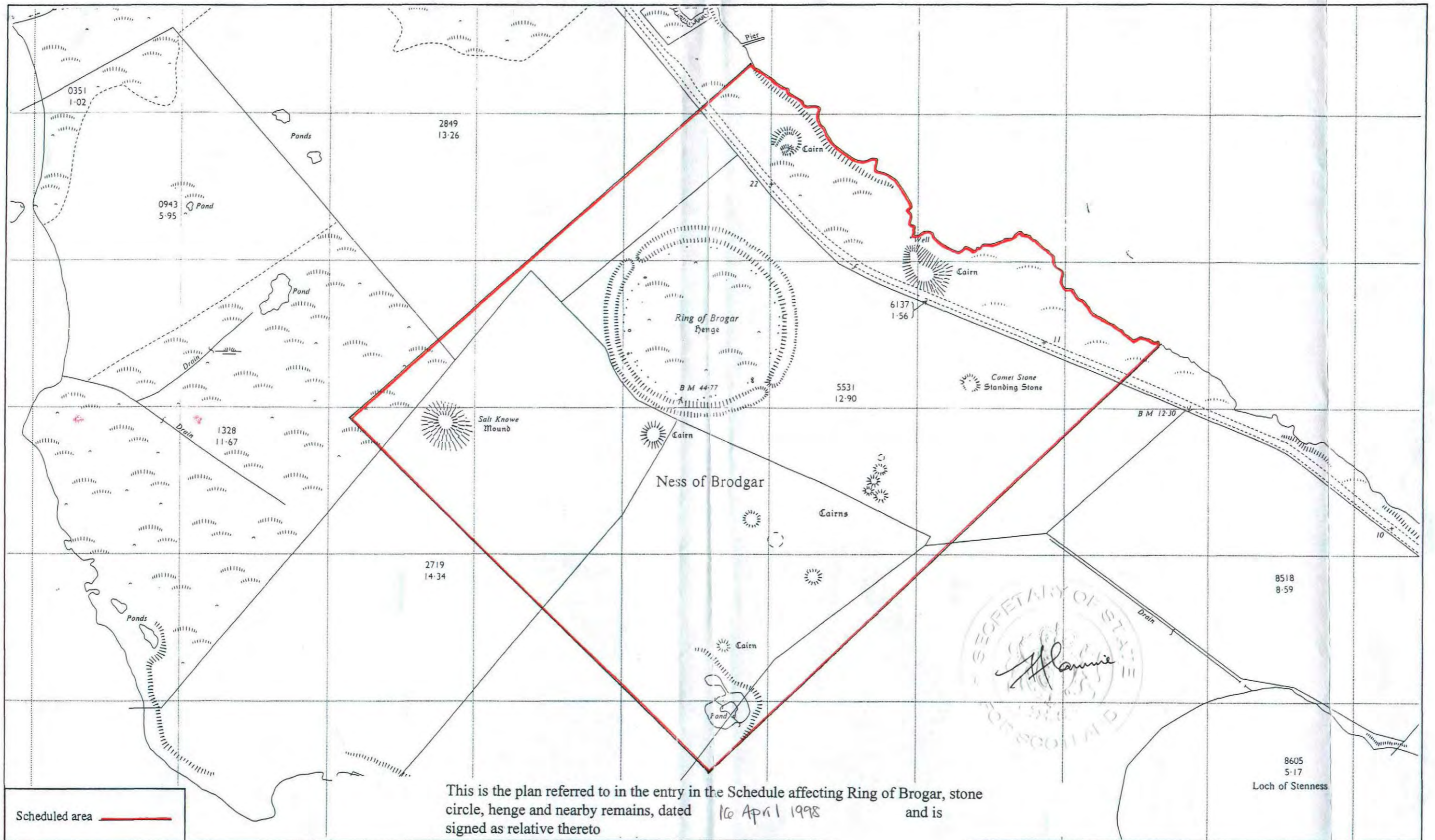
