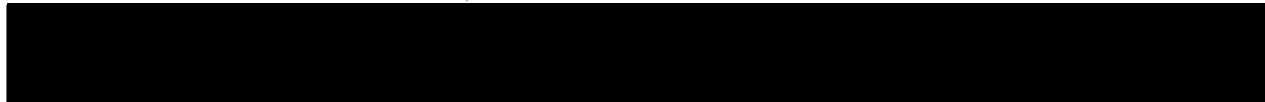

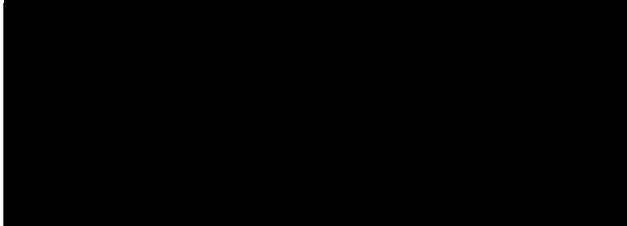

situated in the Parish of Prestonpans and County of East Lothian

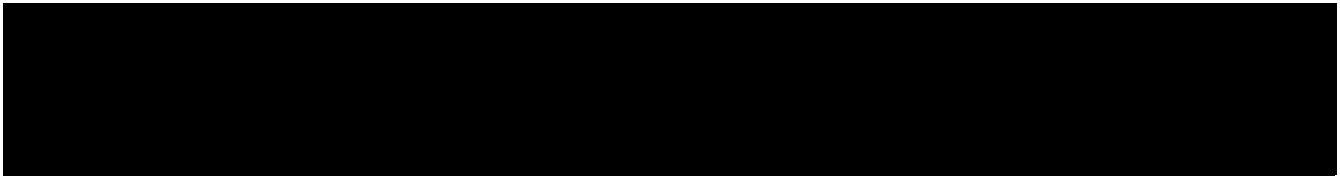

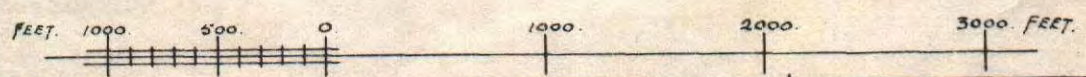
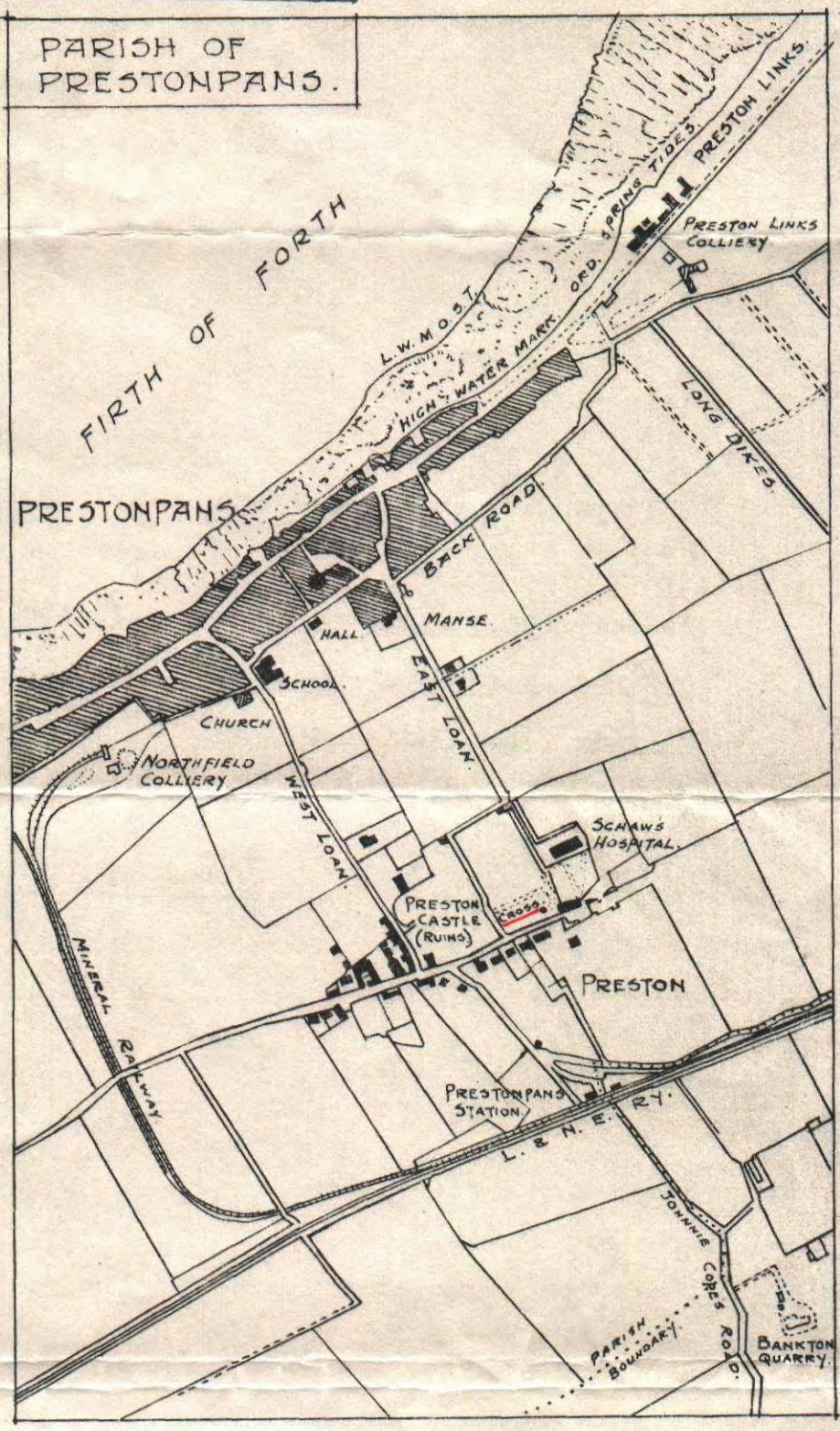
