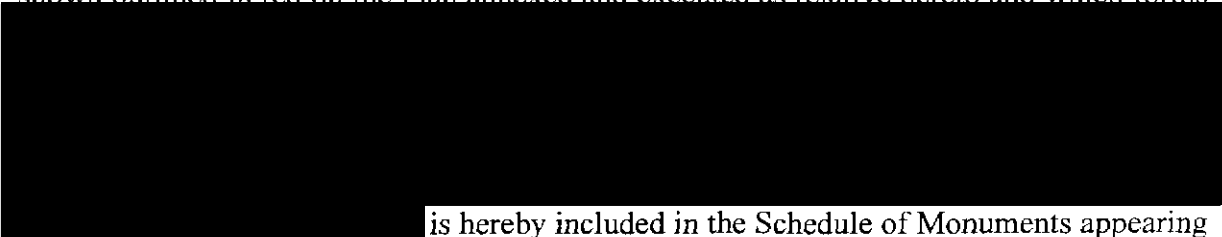

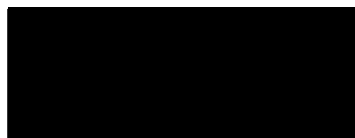
THE ANCIENT MONUMENTS AND ARCHAEOLOGICAL AREAS ACT 1979  
ENTRY IN THE SCHEDULE OF MONUMENTS

The monument known as Cross-Kirk (Westside Church), church and burial ground, Tuquoy, Westray comprises a church of medieval date and a burial ground. The area to be scheduled comprises the remains described and an area around them within which related material may be expected to be found. It is polygonal with maximum dimensions of 70m from its easternmost point to its westernmost point and 70m from its northernmost point to its southernmost point, defined by the outer face of the stone wall enclosing the burial ground. The monument, which lies in the Parish of Westray and the County of Orkney as shown outlined in red on the Plan annexed and executed as relative hereto and which forms



is hereby included in the Schedule of Monuments appearing to the Secretary of State for Scotland to be of national importance compiled and maintained by him under section 1(1) of the Ancient Monuments and Archaeological Areas Act 1979.

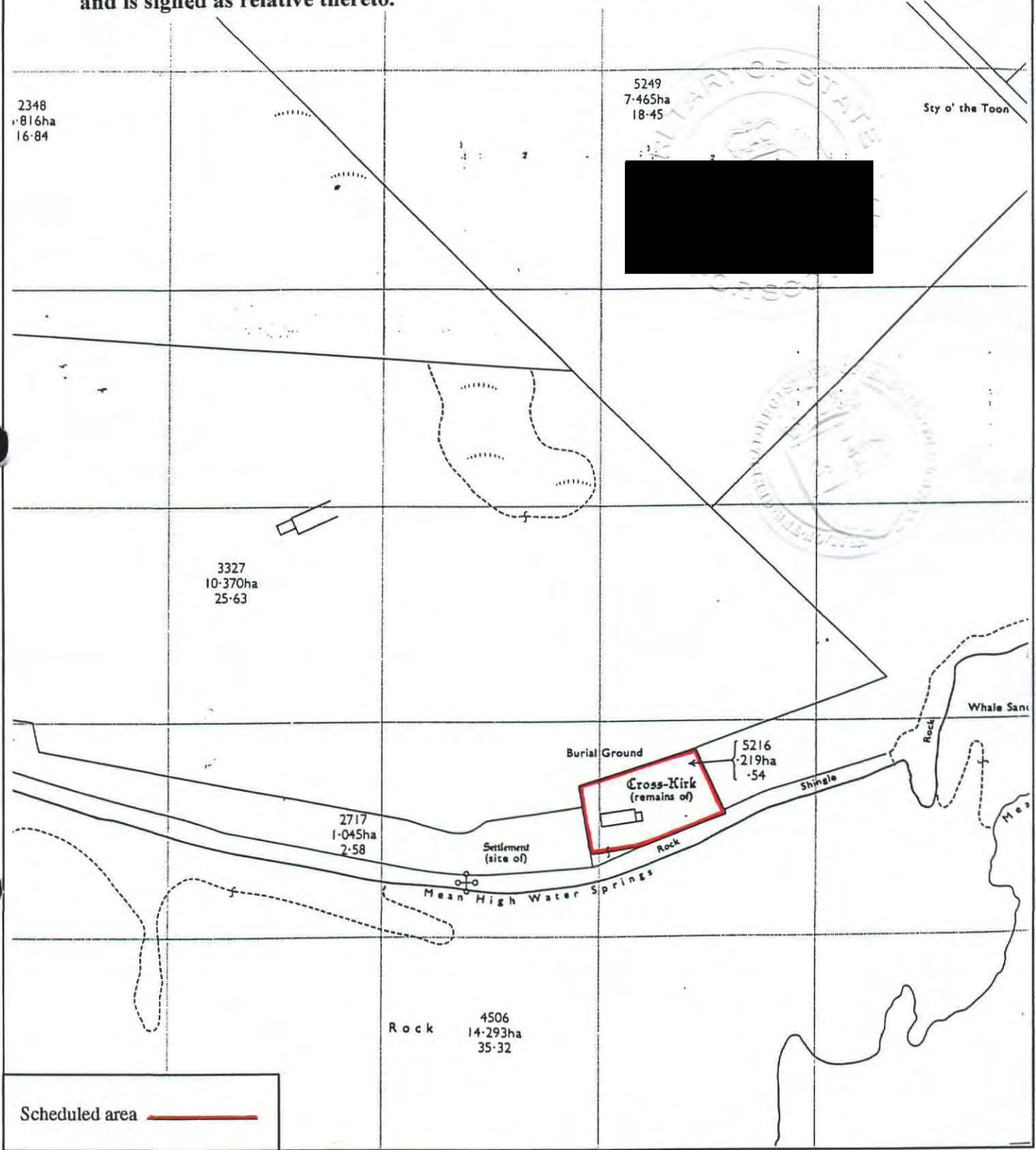

Scheduled area

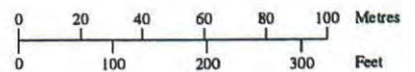
