## **The Ancient Monuments and Archaeological Areas Act 1979**

### **Amended entry in the schedule of monuments**

Historic Environment Scotland in exercise of the powers conferred on it by section 1(5) of the Ancient Monuments and Archaeological Areas Act 1979 hereby amends the following entry in the statutory schedule of monuments:

#### **Roman temporary camp, 40m SW, 75m SW, 75m N and 80m NE of Bents**

**Cottage** comprises The monument comprises the buried remains of a Roman temporary camp. The camp is visible as the cropmarks of its defensive ditches on oblique aerial photographs and sections have been confirmed by geophysical survey and excavation. The majority of the camp lies within the grounds of St Mary's Primary School, Bo'ness, with further remains lying to the north northeast in Kinglass Park and in open ground to the east. The site lies at around 65m above sea level, in the Parish of Bo'ness and Carriden and the County of West Lothian.

The scheduled area is in four sections. It includes the remains described above and an area around within which evidence relating to the monument's construction, use and abandonment is expected to survive, as shown in red on the plan annexed and executed as relative hereto.

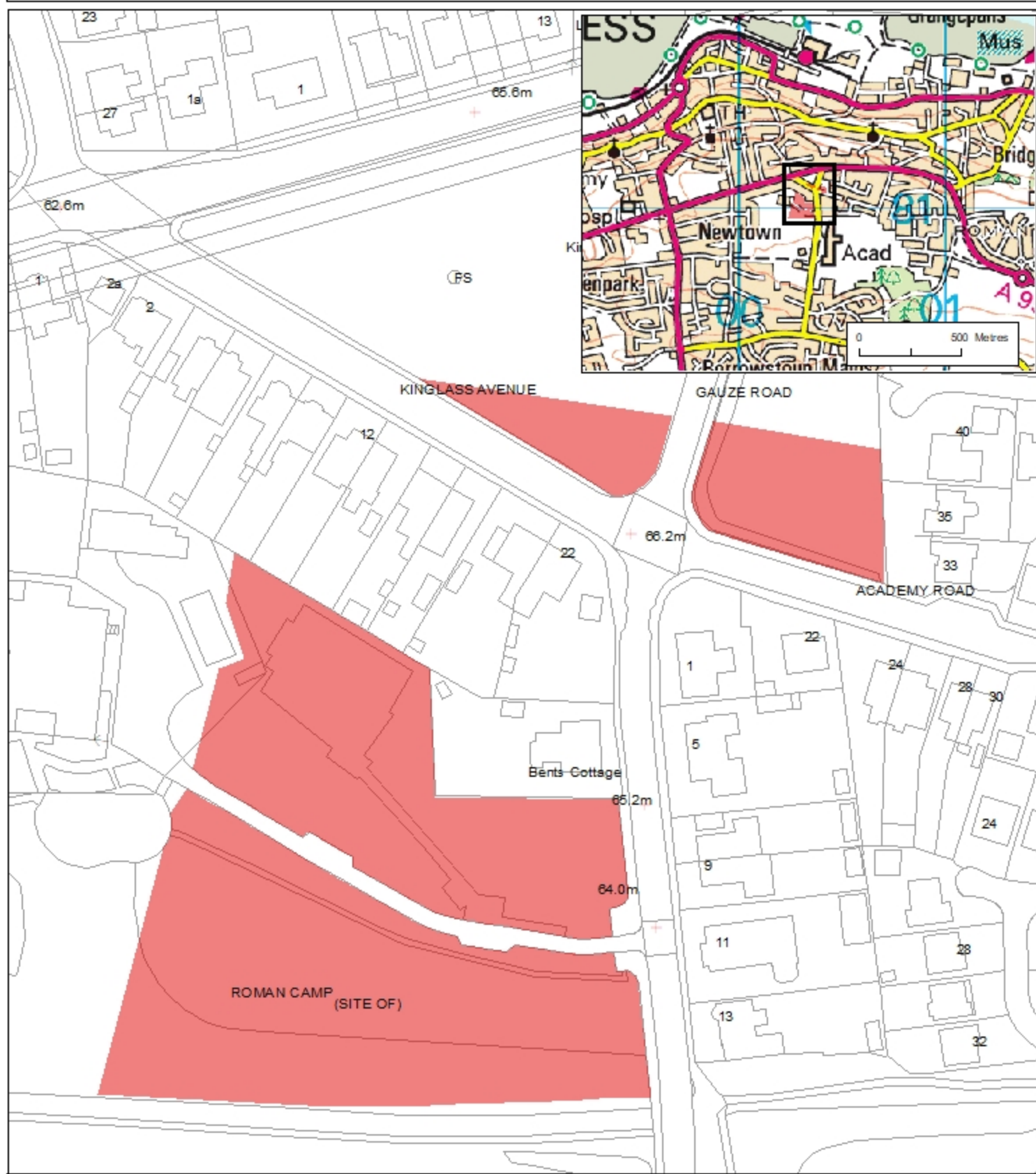
The scheduling specifically excludes the above-ground elements of all fences, brick walls and the top 30cm of all paths and hard standings, to allow for their maintenance.

This entry supersedes the entry in the schedule of monuments for the monument previously known as **Bents Cottage, Roman temporary camp 40m SW, 75m SW & 75m NE of** as referred to in the entry in the schedule of monuments by the Scottish Ministers dated 25 June 2010 and recorded in the General Register of Sasines for the County of West Lothian on 7 October 2010.
